



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: AMH 20142 Borrower LLC

The parties of record before the Property Tax Appeal Board are AMH 20142 Borrower LLC, the appellant, by attorney Michael R. Davies, of the Law Offices of Michael R. Davies, Ltd. in Oak Lawn; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$5,612
IMPR.: \$26,271
TOTAL: \$31,883

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2016 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a two-story dwelling of frame construction with 1,309 square feet of living area. The dwelling was constructed in 1995. Features of the home include a concrete slab foundation, a fireplace and a 253 square-foot attached garage. The property is located in Waukegan, Warren Township, Lake County.

The appellant submitted evidence before the Property Tax Appeal Board claiming overvaluation as the basis of the appeal. In support of the overvaluation claim, the appellant submitted limited descriptive information for ten comparable sales.¹ The properties were reported as being located from 0.02 to 0.07 of a mile from the subject. The ten comparables were reported to consist of two-story dwellings that were built in 1994 or 1995. The comparables were reported to have two

bedrooms and one or two bathrooms. The appellant failed to disclose the comparables' exterior construction, foundation type or features such as central air conditioning, fireplaces or garages. The dwellings have either 1,205 or 1,309 square feet of living area. The comparables sold from December 2012 to May 2015 for prices ranging from \$72,500 to \$93,000 or from \$55.39 to \$77.18 per square foot of living area, land included. Based on this evidence, the appellant requested a reduction in the subject's assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$31,883. The subject's assessment reflects an estimated market value of \$96,149 or \$73.45 per square foot of living area, land included, when applying the 2016 three-year average median level of assessment for Lake County of 33.16%.

The board of review presented information on eight comparable sales with the same neighborhood code as the subject. The properties were reported as being located from 0.026 to 0.168 of a mile from the subject. The comparables are improved with two-story dwellings of frame construction. The dwellings were constructed in 1994 or 1995, and each has 1,309 square feet of living area. Each comparable has a concrete slab foundation, central air conditioning, a fireplace and a 253 square-foot attached garage. The comparables sold from January 2014 to December 2016 for prices ranging from \$100,000 to \$135,000 or from \$76.39 to \$103.13 per square foot of living area, land included. Based on this evidence, the board of review requested confirmation of the subject's assessment.


Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties presented sale prices for 18 comparable properties. The Board finds that eight of the appellant's comparables (#1 through #3, #5 through #7, #9 and #10) sold from December 2012 to October 2014. The Board gave less weight to these comparables because their sales were considered to be dated in relation to the January 1, 2016 assessment date. Board of review comparables #1 and #2 also received less weight due to their 2014 sale dates.

The Board finds the best evidence of market value in the record to be the appellant's comparables #4 and #8 and board of review comparables #3 through #8. The Board finds these six properties were very similar to the subject in location, age and living area and they sold more proximate to the January 1, 2016 assessment date. These comparables sold from February 2015 to December 2016 for prices ranging from \$86,455 to \$135,000 or from \$71.75 to \$103.13 per square foot of living area, land included. The subject's assessment reflects a market value of \$96,149 or \$73.45 per square foot of living area, land included, which falls near the low end of the range established by the best comparable sales in this record on a square foot basis. Based on this record, the Board finds the appellant was not able to demonstrate that the subject was overvalued and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
