

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Jason Brodsky, the appellant, by attorney Ronald Kingsley, of Lake County Real Estate Tax Appeal, LLC in Lake Forest; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>A Reduction</u> in the assessment of the property as established by the Lake County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$39,703 IMPR.: \$215,587 TOTAL: \$255,290

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2016 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a two-story dwelling of wood siding exterior construction with 3,596 square feet of living area. The dwelling was constructed in 2001. Features of the home include an unfinished basement, central air conditioning, one fireplace and a 400 square foot garage. The property is located in Deerfield, West Deerfield Township, Lake County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument the appellant submitted information on five comparable sales located within .66 of a mile of the subject property. The comparables are described as two-story dwellings of brick or wood siding exterior construction ranging in size from 3,111 to 3,800 square feet of living area. The dwellings were constructed from 2001 to 2009. The comparables have basements, with two having finished area. Each comparable has central air conditioning, one fireplace and a garage ranging in size from 440 to 651 square feet of building area. The comparables sold from January

2015 to July 2016 for prices ranging from \$631,500 to \$964,000 or from \$177.64 to \$253.68 per square foot of living area, including land. Based on this evidence, the appellant requested a reduction in the subject's total assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$283,480. The subject's assessment reflects a market value of \$854,885 or \$237.73 per square foot of living area, land included, when using the 2016 three year average median level of assessment for Lake County of 33.16% as determined by the Illinois Department of Revenue.

In support of the subject's assessment, the board of review submitted information on three comparable sales located within .54 of a mile of the subject property, one of which was submitted by the appellant. Board of review comparable #3 is the same property as appellant's comparable #5. The comparables are described as two-story dwellings of wood siding exterior construction ranging in size from 3,411 to 3,800 square feet of living area. The dwellings were constructed from 1999 to 2004. The comparables have basements, with finished area. In addition, each comparable has central air conditioning, one fireplace and a garage ranging in size from 441 to 846 square feet of building area. The comparables sold from October 2015 to June 2016 for prices ranging from \$920,000 to \$980,000 or from \$253.68 to \$272.90 per square foot of living area, including land. Based on this evidence, the board of review requested that the subject property's assessment be confirmed.

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant met this burden of proof and a reduction in the subject's assessment is warranted.

The Board finds the parties submitted seven comparable sales for consideration which includes the parties' common comparable. The Board gave reduced weight to board of review comparables which includes the parties' common comparable along with appellant's comparable #3 for their superior finished basements when compared to the subject's unfinished basement.

The Board finds the best evidence of market value for the subject property to be the remaining comparables submitted by the appellant. These three comparables are similar to the subject in location, dwelling size, design, age and features such as unfinished basements. The comparables sold from January 2015 to March 2016 for prices ranging from \$631,500 to \$755,000 or from \$177.64 to \$230.47 per square foot of living area, including land. The subject's assessment reflects a market value of \$854,885 or \$237.73 square foot of living area, including land which falls above the range established by the best comparable sales in the record. After considering any necessary adjustments to the comparables for differences when compared to the subject, the Board finds the subject's estimated market value as reflected by its assessment is overvalued.

Based on this record, the Board finds the appellant demonstrated by a preponderance of the evidence that the subject was overvalued and a reduction in the subject's assessment is justified.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
