

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Deann Baseley, the appellant, by attorney Ronald Kingsley of Lake County Real Estate Tax Appeal, LLC in Lake Forest; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>No Change</u> in the assessment of the property as established by the Lake County Board of Review is warranted. The correct assessed valuation of the property is:

LAND:	\$3,513
IMPR.:	\$25,159
TOTAL:	\$28,672

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2016 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a one-story dwelling of frame exterior construction with 1,064 square feet of living area. The dwelling was constructed in 1976. Features of the home include a full unfinished basement, central air conditioning and a 576 square foot garage. The property has a 7,250 square foot site and is located in Zion, Zion Township, Lake County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument the appellant submitted information on six comparable sales located between .21 of a mile and 1.05 miles from the subject property. The comparables were described as one-story dwellings of brick or frame exterior construction ranging in size from 957 to 1,158 square feet of living area. The dwellings were constructed from 1911 to 1971. The comparables each have an unfinished basement. Additionally, four comparables have central air conditioning and each comparable has a garage ranging in size from 360 to 600 square feet of building area.

sites ranging in size from 6,006 to 17,227 square feet of land area. The comparables sold from June 2015 to April 2016 for prices ranging from \$40,000 to \$89,900 or from \$36.80 to \$78.37 per square foot of living area, including land. Based on this evidence, the appellant requested a reduction in the subject's assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$28,672. The subject's assessment reflects a market value of \$86,466 or \$81.26 per square foot of living area, land included, when using the 2016 three-year average median level of assessment for Lake County of 33.16% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment, the board of review submitted information on three comparable sales located within .83 of a mile of the subject property. The comparables were described as one-story dwellings of frame exterior construction ranging in size from 912 to 1,176 square feet of living area. The dwellings were constructed from 1974 to 1978. The comparables each have a full unfinished basement. In addition, one comparable has central air conditioning, one comparable has two fireplaces and two comparables have a garage containing either 384 or 480 square feet of building area. The comparables have sites ranging in size from 6,815 to 14,000 square feet of land area. The comparables sold from April 2015 to July 2016 for prices ranging from \$93,000 to \$124,000 or from \$86.67 to \$105.44 per square foot of living area, including land. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and no reduction in the subject's assessment is warranted.

The parties submitted nine comparable sales for the Board's consideration. The Board gave less weight to the appellant's comparables #1, #2 and #4 through #6 due to their dwellings being older in age when compared to the subject. The Board also gave less weight to board of review comparable #1 as it lacks a garage unlike the subject.

The Board finds the best evidence of market value to be the appellant's comparable #3 along with comparables #2 and #3 submitted by the board of review. These comparables are most similar to the subject in location, size, design, age and most features. These comparables sold from April 2015 to April 2016 for prices ranging from \$79,900 to \$124,000 or from \$74.46 to \$105.44 per square foot of living area, including land. The subject's assessment reflects a market value of \$86,466 or \$81.26 per square foot of living area, land included, which falls within the range established by the most similar comparable sales in this record. After considering adjustments to the comparable sales for differences when compared to the subject, the Board finds the estimated market value as reflected by the assessment is supported and no reduction in the subject's assessment is warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND</u> <u>EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
