



**FINAL ADMINISTRATIVE DECISION  
ILLINOIS PROPERTY TAX APPEAL BOARD**

The parties of record before the Property Tax Appeal Board are Kenneth Malo, the appellant, by attorney Andrew J. Rukavina, of The Tax Appeal Company in Mundelein; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$70,747  
**IMPR.:** \$298,832  
**TOTAL:** \$369,579

Subject only to the State multiplier as applicable.

**Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2016 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

**Findings of Fact**

The subject property consists of a two-story dwelling of brick exterior construction with 5,340 square feet of living area. The dwelling was constructed in 1989. Features of the home include a full finished basement, central air conditioning, three fireplaces and a seven-car garage. The property has a 105,381-square foot site and is located in Barrington, Cuba Township, Lake County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument the appellant submitted an appraisal estimating the subject property had a market value of \$950,000 as of January 1, 2016. The appraisal was prepared by William P. Neberieza, a certified residential real estate appraiser. In estimating the market value of the subject property, the appraiser developed the sales comparison approach to value.

Under the sales comparison approach, the appraiser analyzed three comparable sales located from 1.84 to 3.59 miles from the subject property. The comparables consist of two-story dwellings that are 18 or 25 years old. The dwellings had features with varying degrees of similarity when compared to the subject. The dwellings range in size from 5,566 to 7,405 square feet of living area and are situated on sites that range in size from 57,871 to 85,901 square feet of land area. The comparables sold from March to November of 2015 for prices ranging from \$854,000 to \$988,000 or from \$133.42 to \$159.00 per square foot of living area including land. The appraiser made adjustments to each comparable for differences from the subject property to arrive at adjusted prices ranging from \$908,100 to \$963,000. The appellant requested the total assessment be reduced to \$316,635 which would reflect the appraised value.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the subject's final assessment of \$369,579. The subject's assessment reflects an estimated market value of \$1,114,533 or \$208.71 per square foot of living area including land when applying Lake County's 2016 three-year average median level of assessment of 33.16% as determined by the Illinois Department of Revenue. 86 Ill.Admin.Code §1910.50(c)(1).

In support of the subject's assessment, the board of review submitted information on four comparable sales located within 1.16 miles from the subject property. The comparables consist of two-story dwellings<sup>1</sup> that were built from 1984 to 1993. The dwellings had features with varying degrees of similarity when compared to the subject. The dwellings range in size from 4,384 to 5,442 square feet of living area and are situated on sites that range in size from 79,286 to 488,308 square feet of land area. The comparables sold from August 2014 to June 2017 for prices ranging from \$925,000 to \$1,250,000 or from \$202.02 to \$229.69 per square foot of living area including land. The board of review submission included property record cards for the subject and its four comparable sales.

The board of review submission also included a map and memo asserting that the appellant's appraisal comparable sales #1 and #3 are located outside the market area when compared to the subject property. Based on this evidence, the board of review requested confirmation of the subject's assessment.

In written rebuttal, counsel for the appellant critiqued the board of review's submission.

### **Conclusion of Law**

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The record contains an appraisal submitted by the appellant and information on four comparable sales provided by the board of review. The Board gives the final opinion of value found in the

appraisal little weight due to the distant location of the appellant's appraisal comparable sales when compared to the subject property. The Board also gave less weight to the board of review's comparable sale #2 due to its significantly larger land area when compared to the subject property. The Board finds the remaining three comparable sales submitted by the board of review are more similar to the subject in location, age, land area, design and features. They sold from August 2014 to June 2017 for prices ranging from \$925,000 to \$1,250,000 or from \$202.02 to \$229.69 per square foot of living area including land. The subject's assessment reflects an estimated market value of \$1,114,533 or \$208.71 per square foot of living area including land, which falls within the range established by the most similar comparable sales contained in the record. Based on this evidence the Board finds the subject is not overvalued and a reduction in the assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

**IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
