



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: AMH 2014 2 & Borrower LLC
DOCKET NO.: 16-05501.001-R-1

The parties of record before the Property Tax Appeal Board are AMH 2014 2 & Borrower LLC, the appellant, by attorney Michael R. Davies of Ryan Law LLP in Chicago; and the McHenry County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **no change** in the assessment of the property as established by the **McHenry** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$12,399
IMPR.: \$49,035
TOTAL: \$61,434

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the McHenry County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2016 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a split-level dwelling of vinyl siding exterior construction with 1,456 square feet of above grade living area. The dwelling was constructed in 2002. Features of the home include a 780 square foot finished lower level, a partial unfinished basement, central air conditioning, a fireplace and a three-car garage.¹ The property has an 11,340 square foot site and is located in McHenry, McHenry Township, McHenry County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument, the appellant submitted a list of four comparable sales that sold from February 2013 to February 2015 for prices ranging from \$123,000 to \$160,000. The appellant provided no substantive

descriptive information about the comparables other than that the dwellings were built in either 1985 or 2001 and range in size from 1,664 to 2,573 square feet of above grade living area. Based on this evidence, the appellant requested a reduction in the subject's assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$61,434. The subject's assessment reflects a market value of \$184,542 or \$126.75 per square foot of above grade living area, land included, when using the 2016 three-year average median level of assessment for McHenry County of 33.29% as determined by the Illinois Department of Revenue.

In response to the appeal, the board of review asserted that three of the appellant's comparables sold in 2013, which are dated. The board of review also noted that based upon the three comparable sales gathered by the township assessor, the subject is under-assessed.

In support of its contention of the correct assessment, the board of review submitted evidence provided by the McHenry Township Assessor's office, which included information on three comparable sales located in the same subdivision as the subject property. Each comparable has either a 10,960 or 11,138 square foot site. The comparables were improved with split-level dwellings each containing 1,456 square feet of above grade living area that were built from 1999 to 2001. The comparables each feature 780 square feet of finished lower level; two comparables have unfinished basements; and each comparable has central air conditioning and a two-car garage. The comparables sold in September 2015 and April 2016 for prices ranging from \$177,900 to \$210,100 or from \$122.18 to \$144.30 per square foot of above grade living area, including land.

While the board of review noted the subject appeared to be under-valued, the board of review did not request a change in the subject's assessment.

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties provided a total of seven comparable sales to support their respective positions before the Property Tax Appeal Board. Little weight was given to the appellant's evidence as it contained no substantive descriptive information about the dwellings to allow the Property Tax Appeal Board to conduct a meaningful comparative analysis of the comparable sales as compared to the subject property. Additionally, three of the appellant's comparables sold in 2013, not as proximate in time to the assessment date as the sales provided by the board of review.

The Board finds the best evidence of market value to be the three comparable sales submitted by the board of review. These comparables are similar to the subject in location, dwelling size,

design, age and features. These comparables sold from September 2015 and April 2016 for prices ranging from \$177,900 to \$210,000 or from \$122.18 to \$144.30 per square foot of above grade living area, including land. The subject's assessment reflects a market value of \$184,542 or \$126.75 per square foot of above grade living area, including land, which falls within the range established by the best comparable sales in the record. Based on this record, the Board finds no reduction in the subject's assessment is warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
