

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: AH4R I IL LLC DOCKET NO.: 16-05530.001-R-1 PARCEL NO.: 18-34-328-012

The parties of record before the Property Tax Appeal Board are AH4R I IL LLC, the appellant, by attorney Michael R. Davies, of Ryan Law LLP, in Chicago, and the McHenry County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>no change</u> in the assessment of the property as established by the **McHenry** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$5,835 IMPR.: \$61,500 TOTAL: \$67,335

Subject only to the State multiplier as applicable.

### **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the McHenry County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2016 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

#### **Findings of Fact**

The subject property consists of a two-story dwelling of frame exterior construction with 1,979 square feet of living area. The dwelling was constructed in 1999. Features of the home include a full basement, central air conditioning and a 630 square foot garage. The property has a 9,000 square foot site and is located in Huntley, Grafton Township, McHenry County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument, the appellant submitted a list of nine comparable sales that sold from January 2013 to April 2015 for prices ranging from \$145,000 to \$202,000. The appellant provided no substantive descriptive

information about the comparables other than that the dwellings were built between 1999 and 2003 and range in size from 1,759 to 2,566 square feet of above grade living area.

Based on this evidence, the appellant requested the subject's assessment be reduced to \$48,333 which would reflect a market value of \$145,000.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$67,335. The subject's assessment reflects a market value of \$202,268 or \$102.21 per square foot of living area, land included, when using the 2016 three year average median level of assessment for McHenry County of 33.29% as determined by the Illinois Department of Revenue.

In response to the appeal, the board of review noted that based upon comparable sales gathered by the township assessor, the subject property is "under-assessed."

In support of its contention of the correct assessment, the board of review submitted information on four comparable sales each of which is located in the same neighborhood code assigned by the assessor. The comparables consist of two-story dwellings of frame or frame and brick exterior construction. The homes were each built in 1999 and range in size from 1,846 to 1,995 square feet of living area. Each comparable has a basement and a garage ranging in size from 418 to 630 square feet of building area. Three comparables each have a fireplace and no data was provided concerning central air conditioning. The comparables sold between August 2015 and April 2016 for prices ranging from \$225,000 to \$256,500 or from \$112.78 to \$134.15 per square foot of living area, including land.

While the board of review noted the subject appeared to be under-valued, the board of review did not request a change in the subject's assessment.

#### **Conclusion of Law**

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties provided a total of thirteen comparable sales to support their respective positions before the Property Tax Appeal Board. The Board finds that little weight shall be given to the appellant's evidence as it contained no substantive descriptive information about the dwellings to allow the Property Tax Appeal Board to conduct a meaningful comparative analysis of the comparable sales as compared to the subject property. Additionally, eight of the appellant's comparables sold in 2013and 2014, not as proximate in time to the assessment date as the sales provided by the board of review.

The Board finds the best evidence of market value to be the board of review comparable sales. These four comparables are highly similar to the subject in location, age, design, exterior

construction and several features. These comparables sold between August 2015 and April 2016 for prices ranging from \$225,000 to \$256,500 or from \$112.78 to \$134.15 per square foot of living area, including land. The subject's assessment reflects a market value of \$202,268 or \$102.21 per square foot of living area, including land, which is below the range established by the best comparable sales in this record both in terms of overall value and on a per-square-foot basis. As noted by the McHenry County Board of Review, based on the best market value evidence in the record, the subject property appears to be under-assessed.

On this record, the Board finds no reduction in the subject's assessment is warranted.

#### **IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
