

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: DACS LLC SERIES 11

The parties of record before the Property Tax Appeal Board are DACS LLC SERIES 11, the appellant, by attorney Michael R. Davies, of Ryan Law LLP in Chicago; and the DuPage County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **DuPage** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$3,620 **IMPR.:** \$16,520 **TOTAL:** \$20,140

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the DuPage County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2016 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a one-story condominium unit of brick exterior construction with 760 square feet of living area. The dwelling was constructed in 1965 and features a fireplace. The property is located in Lisle, Lisle Township, DuPage County.

The appellant submitted evidence before the Property Tax Appeal Board claiming overvaluation as the basis of the appeal. In support of the overvaluation claim, the appellant submitted limited descriptive information for five comparable properties that were reported to be located .09 of a mile from the subject property. The Board requested that the appellant complete the grid analysis in Section V of the appeal petition. The appellant failed to comply with the Board's request and failed to disclose the comparables' design, exterior construction, foundation type and features such as central air conditioning, fireplaces and garages. The comparables were reported to be built in 1980 and range in size from 670 to 870 square feet of above grade living area. The

comparables sold from October 2012 to May 2014 for prices ranging from \$53,000 to \$59,000 or from \$63.22 to \$88.06 per square foot of above grade living area, land included. Based on this evidence, the appellant requested a reduction in the subject's assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$20,140. The subject's assessment reflects a market value of \$60,499 or \$79.60 per square foot of living area, land included, when using the 2016 three-year average median level of assessment for DuPage County of 33.29% as determined by the Illinois Department of Revenue.

In response to the appellant's submission, the board of review submitted a grid analysis of the appellant's comparables and a map that depicted the locations of both parties comparables and the subject.

In further support of its contention of the correct assessment, the board of review submitted a grid analysis on five comparable sales located in the same neighborhood code as the subject as defined by the township assessor. The comparables are described as condominium units of brick exterior construction containing either 730 or 760 square feet of living area. The comparables were built in 1965. Three comparables have a fireplace. The comparables sold from December 2014 to January 2016 for prices ranging from \$63,530 to \$85,500 or from \$83.59 to \$112.50 per square foot of living area, including land. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The Board finds the parties submitted ten comparable sales for consideration. The Board gave less weight to appellant's comparables along with board of review comparables #4 and #5 as to their dated sales from 2012 to 2014 were less reflective of market value as of the subject's January 1, 2016 assessment date.

The Board finds the best evidence of market value to be the remaining board of review comparables. These three comparables sold most proximate in time to the subject's January 1, 2016 assessment date and are most similar to the subject in location, design, age, dwelling size and features. The comparables sold in June 2015 and January 2016 for prices ranging from \$63,530 to \$73,500 or from \$83.59 to \$96.71 per square foot of living area, including land. The subject's assessment reflects a market value of \$60,499 or \$79.60 per square foot of living area including land which falls below the range established by the most similar comparable sales in this record. Based on this record, the Board finds the appellant failed to demonstrate by a preponderance of the evidence that the subject was overvalued and a reduction in the subject's assessment is not justified.

Date:

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
