

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Katarzyna Kornecka DOCKET NO.: 16-20013.001-R-1 PARCEL NO.: 10-24-215-006-0000

The parties of record before the Property Tax Appeal Board are Katarzyna Kornecka, the appellant; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$6,158 IMPR.: \$25,105 TOTAL: \$31,263

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2016 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 128-year old, one and one-half story dwelling of stucco construction with 1,357 square feet of living area. Features of the home include: a full basement, central air conditioning, one bathroom, and a two-car garage. The property has a 6,158 square foot site and is located in Evanston Township, Cook County. The subject is classified as a class 2, residential property under the Cook County Real Property Assessment Classification Ordinance.

Procedurally, this matter was set for hearing on November 1, 2018. However, the appellant requested a postponement due to her absence outside of the country without objection from the board of review. Therefore, the Board granted the appellant's request. The appellant further indicated that she would be out of the country until August, 2019. Therefore, the parties were asked if they wanted to waive their right to hearing and proceed with a Board decision rendered on the written evidence. Both parties had no objections and waived their right to a hearing.

The appellant contends assessment inequity as the basis of the appeal. In support of this argument, the appellant submitted information on four suggested equity comparables. They were located from two blocks to a one-mile radius from the subject and contain a one and one-half story dwelling of frame, stucco or frame and masonry exterior construction. The improvements ranged: in age from 102 to 118 years; in number of dwelling units from one to two; in improvement size from 1,255 to 1,618 square feet of living area; and in improvement assessments from \$12.02 to \$12.94 per square foot of living area. Amenities included: a full basement, one or two bathrooms, while properties #2 through #4 also contained a two-car garage.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$31,263. The subject property has an improvement assessment of \$25,105 or \$18.50 per square foot of living area. In support of its contention of the correct assessment, the board of review submitted information on four suggested equity comparables that were all single-family dwellings. They were located either on the subject's block or within a two-block radius from the subject and contained a one and one-half story dwelling of stucco exterior construction. The improvements ranged: in age from 103 to 128 years; in improvement size from 1,249 to 1,411 square feet of living area; and in improvement assessments from \$19.40 to \$30.23 per square foot of living area. Amenities included: a full basement, one or two bathrooms, as well as a two-car or two and one-half car garage.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant *did not meet* this burden of proof and a reduction in the subject's assessment *is not* warranted.

The Board finds the best evidence of assessment equity to be the appellant's comparables #2 as well as the board of review's comparables #1, #3 and #4. These four comparables had improvement assessments that ranged from \$12.02 to \$20.51 per square foot of living area. The subject's improvement assessment of \$18.50 per square foot of living area falls within the range established by the best comparables in this record. The remaining properties were accorded less weight due to a disparity in location, style, number of units, improvement age, improvement size and/or variance in amenities. Based on this record, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
