

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: April Victor

The parties of record before the Property Tax Appeal Board are April Victor, the appellant, by attorney Noah J. Schmidt, of Schmidt Salzman & Moran, Ltd. in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>A Reduction</u> in the assessment of the property as established by the Cook County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$10,497 **IMPR.:** \$62,320 **TOTAL:** \$72,817

Subject only to the State multiplier as applicable.

### **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2016 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

#### **Findings of Fact**

The subject property is improved with a 2-story frame dwelling containing 3,280 square feet of living area. The dwelling is 24 years old and features a full unfinished basement, central air conditioning, a fireplace and a 2-car garage. The subject is located in Glenview, New Trier Township, Cook County. The subject property is classified as a Class 2-78 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity and a contention of law as the bases of the appeal. In support of the inequity argument the appellant submitted information on five assessment comparables. They consist of 2-story, Class 2-78 dwellings having the same neighborhood code as the subject. They range in size from 3,244 to 3,351 square feet of living area and range in age from 1 to 60 years old. Four comparables have full or partial basements, three with finished area, and one has no basement. They feature central air conditioning and 1, 1½ or 2-car garages.

Four comparables feature fireplaces. The comparables have improvement assessments ranging from \$56,376 to \$59,380 or from \$17.38 to \$17.99 per square foot of living area.

The appellant's attorney also submitted a brief requesting "the 2016 assessment on the subject be revised to reflect a building assessed value of \$17.72 per square foot (median of the comparables cited) which indicates a revised assessment of \$68,618." Based on this evidence, the appellant requested the subject's 2016 improvement assessment be reduced to \$58,121 or \$17.72 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$76,425. The subject property has an improvement assessment of \$65,928 or \$20.10 per square foot of living area.

In support of the subject's assessment, the board of review submitted information on four 2-story Class 2-78 comparables having the same neighborhood code as the subject. The dwellings are either 16 or 22 years old and range in size from 2,664 to 3,104 square feet of living area. The comparables have full unfinished basements, central air conditioning, one fireplace each and 2-car garages. The comparables have improvement assessments ranging from \$43,907 to \$60,900 or from \$16.48 to \$19.95 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

# **Conclusion of Law**

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant met this burden of proof and a reduction in the subject's assessment is warranted.

The parties submitted nine assessment comparables for the Board's consideration. The Board gave less weight to board of review comparables #1 and #2 due to their significantly smaller dwelling sizes as compared to the subject. The Board also gave less weight to the appellant's comparables due to dissimilarities to the subject in age and/or features including basement finish or lack of basement. The Board finds board of review comparables #3 and #4 are most similar to the subject in location, style, dwelling size, and features and are slightly newer than the subject. These comparables have improvement assessments of \$59,431 and \$60,900 or \$19.95 and \$19.62 per square foot of living area, respectively. The subject property has an improvement assessment of \$65,928 or \$20.10 per square foot of living area which is not supported by the improvement assessments of the best comparables in this record. After considering adjustments to these comparables for differences to the subject, the Board finds the subject's assessment is not supported. Thus, the Board finds the appellant demonstrated with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's improvement assessment is warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

#### **IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
