

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Jolie Schwartz, the appellant, by attorney Noah J. Schmidt, of Schmidt Salzman & Moran, Ltd. in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$9,009 **IMPR.:** \$40,846 **TOTAL:** \$49,855

Subject only to the State multiplier as applicable.

### **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2016 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

#### **Findings of Fact**

The subject property consists of a 1-story dwelling of frame and masonry exterior construction with 1,674 square feet of living area. The dwelling is approximately 56 years old. Features of the home include a full unfinished basement, central air conditioning, a fireplace and a 1.5-car garage. The property has an 8,580 square foot site and is located in Wilmette, New Trier Township, Cook County. The subject is classified as a class 2-03 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity and contention of law as the bases of the appeal. In support of the inequity argument the appellant submitted information on five equity comparables with the same neighborhood and classification codes as the subject property. The comparables are improved with 1-story dwellings of masonry or frame and masonry exterior construction that range in age from 59 to 61 years old. The comparables have partial or full basements, two of

which have finished areas. Four of the comparables have central air conditioning; two of the comparables have a fireplace and four comparables have a 1.5-car or 2-car garage. The dwellings range in size from 1,626 to 1,725 square feet of living area and have improvement assessments ranging from \$35,920 to \$38,061 or from \$21.86 to \$22.56 per square foot of living area. The appellant also partially completed Section IV-Recent Sale Data of the appeal petition indicating the subject property was purchased March 1, 2015, for a price of \$550,000.

The appellant's attorney also submitted a brief requesting "the 2016 assessment on the subject be revised to reflect a building assessed value of \$22.07 per square foot (median of the comparables cited) which indicates a revised assessment of \$45,954." Based on this evidence, the appellant requested the subject's 2016 improvement assessment be reduced to \$36,945 or \$22.07 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$49,855. The subject property has an improvement assessment of \$40,846 or \$24.40 per square foot of living area. The subject's assessment reflects a market value of \$498,550 or \$297.82 per square foot of living area, land included, when using the level of assessments for class 2 property of 10% under the Cook County Real Property Assessment Classification Ordinance.

In support of its contention of the correct assessment the board of review submitted information on three equity comparables with the same neighborhood and classification codes as the subject property. The homes were described as being located on the same block as the subject property. The comparables are improved with 1-story dwellings of frame and masonry exterior construction that are 59 or 61 years old. The comparables have partial or full basements, one of which has finished area. All have central air conditioning, one or two fireplaces and a 1-car or 2-car garage. The dwellings range in size from 1,306 to 1,766 square feet of living area and have improvement assessments ranging from \$33,863 to \$44,135 or from \$24.45 to \$27.63 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

#### **Conclusion of Law**

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted information on a total of eight suggested equity comparables for the Board's consideration. The Board gave less weight to the board of review's comparables #2 and #3 due to their smaller dwelling sizes when compared to the subject property. The Board finds the appellant's comparables and board of review comparable #1 are more similar when compared to the subject in location, age, dwelling size, design and most features. These

comparables have improvement assessments ranging from \$35,920 to \$44,135 or from \$21.86 to \$24.99 per square foot of living area. The subject's improvement assessment of \$40,846 or \$24.40 per square foot of living area falls within the range established by the best comparables contained in this record. Furthermore, the Board finds the assessment reflects a market value below the March 2015 purchase price of \$550,000. Based on this record, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

The Board finds appellant's contention of law argument was not supported with legal citation and therefore is given no weight in this decision.

#### **IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
