



**FINAL ADMINISTRATIVE DECISION  
ILLINOIS PROPERTY TAX APPEAL BOARD**

The parties of record before the Property Tax Appeal Board are Frank Bernero, the appellant, by attorney Timothy E. Moran, of Schmidt Salzman & Moran, Ltd. in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$11,056  
**IMPR.:** \$76,725  
**TOTAL:** \$87,781

Subject only to the State multiplier as applicable.

**Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2016 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

**Findings of Fact**

The subject property consists of a two-story dwelling of masonry construction. The dwelling is approximately 19 years old and has 5,115 square feet of living area. Features of the home include a partial finished basement, central air conditioning, two fireplaces and a three-car garage. The property has a 40,206 square-foot site and is located in Barrington, Barrington Township, Cook County. The subject is classified as a class 2-09 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity as the basis of the appeal. In support of this argument, the appellant submitted information on five equity comparables with the same classification code as the subject. Three of the comparables have the same neighborhood code as the subject. The comparables are improved with two-story dwellings of frame, masonry or frame and masonry construction. The dwellings are from 17 to 120 years old and contain from 5,040 to 5,606 square feet of living area. The comparables have full or partial unfinished basements.

Four comparables have central air conditioning and from one to four fireplaces. The comparables have garages that range from two-car to four-car. The comparables have improvement assessments that range from \$64,676 to \$80,905 or from \$12.72 to \$14.56 per square foot of living area. Based on this evidence, the appellant requested a reduction in the subject's improvement assessment to \$66,136 or \$12.93 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" wherein the subject's final assessment of \$87,781 was disclosed. The subject property has an improvement assessment of \$76,725 or \$15.00 per square foot of living area. The board of review presented descriptions and assessment information on four comparable properties that have the same neighborhood and classification codes as the subject. The comparables were described as being located on the same block or a quarter-mile from the subject property. The comparables are improved with two-story dwellings of masonry construction. The dwellings are from nine to twenty-four years old and contain from 5,169 to 5,331 square feet of living area. The comparables have full basements, with two having finished areas. Each comparable has central air conditioning, from one to three fireplaces, and a garage, either three-car or four-car. The comparable properties have improvement assessments that range from \$89,382 to \$99,738 or from \$17.10 to \$19.30 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

### **Conclusion of Law**

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties presented assessment data on a total of nine suggested comparables. The Board finds none of the appellant's comparables have a finished basement like the subject; the appellant's comparables #1 and #2 were significantly older than the subject; and comparable #2 lacked central air conditioning. As a result, the appellant's comparables received reduced weight in the Board's analysis. Board of review comparables #3 and #4 received reduced weight, because these comparables also lacked finished basements. The Board finds the best evidence of assessment equity to be board of review comparables #1 and #2. The Board finds these two are the only comparables in the record to have finished basements and they were also very similar to the subject in location, two-story design, masonry construction, age and living area. Board of review comparables #1 and #2 have improvement assessments of \$89,382 and \$91,177 or \$17.10 and \$17.20 per square foot of living area, respectively. The subject's improvement assessment of \$76,725 or \$15.00 per square foot of living area falls below the improvement assessments of the best comparables in this record. After considering adjustments to the comparables for differences from the subject, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.



**IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
