



**FINAL ADMINISTRATIVE DECISION  
ILLINOIS PROPERTY TAX APPEAL BOARD**

The parties of record before the Property Tax Appeal Board are Jeffrey Mackevich, the appellant, by attorney Robert Rosenfeld, of Robert H. Rosenfeld and Associates, LLC in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the Cook County Board of Review is warranted. The correct assessed valuation of the property is:

**Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2016 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

**Findings of Fact**

The subject property consists of two parcels, 05-34-401-017-0000 and 05-34-402-012-0000. The parcels are improved with a 2-story stucco dwelling containing 2,456 square feet of living area. The dwelling is 100 years old and features a full unfinished basement and 2 fireplaces. The subject is located in Wilmette, New Trier Township, Cook County. It is classified as a Class 2-06 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity as the basis of the appeal. In support of this argument the appellant submitted information on three, 2-story, Class 2-06 comparables. The comparables have the same neighborhood code as the subject. They are 104 or 124 years old and range in size from 2,761 to 2,916 square feet of living area. The comparables feature basements, two with finished areas, fireplaces, and 1, 2 or 2½-car garages. Two comparables feature central air conditioning. The comparables have improvement assessments ranging from \$69,190 to

\$73,074 or \$25.06 and \$25.11 per square foot of living area. The appellant's attorney submitted an Addendum to Petition disclosing the board of review improvement assessments for each parcel. The appellant contends parcel 401-017 has an improvement assessment of \$65,934 and a total assessment of \$84,318. The appellant also contends parcel 402-012 has an improvement assessment of \$156 and a total assessment of \$6,996. Based on these values, subject has a combined improvement assessment for both parcels of \$66,090 and a combined total assessment for both parcels of \$91,314. The appellant's attorney also submitted a brief requesting the subject's total combined assessment for both parcels be reduced to \$79,980. The appellant also submitted the 2016 decision from the Cook County Board of Review disclosing the total assessments for each of the two parcels at issue. Based on this evidence the appellant requested the subject's improvement assessment for parcel 401-017 be reduced to \$54,600 and the improvement assessment for parcel 402-012 remain unchanged at \$156, resulting in a combined improvement assessment for both parcels of \$54,756 or \$22.29 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for parcel 05-34-401-017-0000 only. This parcel has an improvement assessment of \$65,934. The board of review did not disclose any information on parcel 05-34-402-012-0000.

In support of the assessment the board of review submitted information on four, 2-story, Class 2-06 comparables having the same neighborhood code as the subject. Two comparables are located in the same tax block as the subject and two are located within a quarter-mile of the subject. The comparables range in age from 99 to 107 years old and range in size from 2,254 to 2,598 square feet of living area. They feature basements, one with finished area, 1 or 2 fireplaces and 1 or 2-car garages. Two comparables feature central air conditioning. The comparables have improvement assessments ranging from \$63,856 to \$73,290 or from \$28.14 to \$28.33 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

### **Conclusion of Law**

The appellant contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted a total of seven comparables for the Board's consideration. The Board gives equal weight to both parties' comparables which have varying degrees of similarity to the subject in location, age, style, dwelling size and features. These comparables have improvement assessments ranging from \$63,856 to \$73,290 or from \$25.06 to \$28.33 per square foot of living area. The appellant disclosed the combined improvement assessment for both parcels of \$66,090 or \$26.91 per square foot of living area which is within the range established by the comparables in the record. After considering adjustments to the comparables for differences to the subject, the Board finds the appellant did not demonstrate with clear and convincing evidence that the

subject's improvement was inequitably assessed and a reduction in the subject's improvement assessment based on inequity is not warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

**IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
