

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Patrick O'Connell DOCKET NO.: 16-21533.001-R-1 PARCEL NO.: 23-02-214-007-0000

The parties of record before the Property Tax Appeal Board are Patrick O'Connell, the appellant, by attorney John S. Xydakis, of the Law Offices of John S. Xydakis in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$5,507 IMPR.: \$12,898 TOTAL: \$18,405

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2016 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a multi-level dwelling of frame and masonry construction. The dwelling is 48 years old and has 1,402 square feet of living area. Features of the home include a partial finished basement, central air conditioning and a two-car garage. The property has a 10,014 square-foot site and is located in Hickory Hills, Palos Township, Cook County. The subject is classified as a class 2-34 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity as the basis of the appeal. The subject's land assessment is not being contested in this appeal. In support of the inequity argument, the appellant submitted information on four equity comparables with the same neighborhood and classification codes as the subject. The comparables are improved with multi-level dwellings of frame, masonry or frame and masonry construction. The dwellings are from 44 to 48 years old

and contain from 1,507 to 1,947 square feet of living area. Each comparable has a partial basement; three comparables have central air conditioning; and one comparable has a fireplace. Information regarding garages was not provided on the appellant's grid analysis; however, the appellant's photographic evidence revealed that each comparable has a garage. The appellant also submitted a map which revealed that the comparables were located near the subject property. The comparables have improvement assessments ranging from \$10,543 to \$17,192 or from \$6.73 to \$8.83 per square foot of living area. Based on this evidence, the appellant requested a reduction in the subject's improvement assessment to \$10,641 or \$7.59 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" wherein the subject's final assessment of \$18,405 was disclosed. The subject property has an improvement assessment of \$12,898 or \$9.20 per square foot of living area. The board of review presented descriptions and assessment information on three comparable properties. The comparables have the same neighborhood and classification codes as the subject and were described as being located on the same block as the subject property. The comparables are improved with multi-level dwellings of frame and masonry construction. The dwellings are 48 years old and contain either 1,402 or 1,682 square feet of living area. Each comparable has a partial finished basement and a two-car garage. Two comparables have central air conditioning. The board of review's comparable properties have improvement assessments ranging from \$16,389 to \$16,664 or from \$9.88 to \$11.87 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties presented assessment data on a total of seven suggested comparables. The Board finds the appellant's comparable #4 had significantly more living area than the subject and received reduced weight in the Board's analysis. The Board finds the best evidence of assessment equity to be the appellant's comparables #1 through #3 and the comparables submitted by the board of review. The Board finds these six comparables were very similar to the subject in location, multi-level design, age, living area and foundation. These comparables had improvement assessments that ranged from \$10,543 to \$16,644 or from \$6.73 to \$11.87 per square foot of living area. The subject's improvement assessment of \$12,898 or \$9.20 per square foot of living area falls within the range established by the best comparables in this record. Based on this record, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

Date:

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
