

### FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Kathryn Motto, the appellant, by attorney John S. Xydakis, of the Law Offices of John S. Xydakis in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>No Change</u> in the assessment of the property as established by the Cook County Board of Review is warranted. The correct assessed valuation of the property is:

LAND:	\$3,592
IMPR.:	\$6,030
TOTAL:	\$9,622

Subject only to the State multiplier as applicable.

#### **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2016 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

#### **Findings of Fact**

The subject property consists of a 1-story dwelling of frame construction. The dwelling is 58 years old and has 1,206 square feet of living area. Features of the home include a concrete slab foundation, central air conditioning, a fireplace and a 2-car garage. The property has an 11,055 square-foot site and is located in Tinley Park, Bremen Township, Cook County. The subject is classified as a class 2-03 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity as the basis of the appeal. The subject's land assessment is not being contested in this appeal. In support of the inequity argument, the appellant submitted information on four equity comparables with the same neighborhood and classification codes as the subject. The comparables are improved with two, 1-story and two,  $1\frac{1}{2}$ -dwellings of frame or masonry construction. The dwellings are from 65 to 102 years old and

contain from 1,233 to 1,691 square feet of living area. Each comparable has a basement, and two comparables have central air conditioning. Information regarding garages was not provided on the appellant's grid analysis; however, the appellant's photographic evidence revealed that at least one of the appellant's comparables has a garage. The appellant also submitted a map which revealed two of the comparables were located near the subject property. The comparables have improvement assessments ranging from \$3,064 to \$5,920 or from \$2.29 to \$3.50 per square foot of living area. Based on this evidence, the appellant requested a reduction in the subject's improvement assessment to \$3,461 or \$2.87 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" wherein the subject's final assessment of \$9,622 was disclosed. The subject property has an improvement assessment of \$6,030 or \$5.00 per square foot of living area. The board of review presented descriptions and assessment information on four comparable properties with the same neighborhood and classification codes as the subject. Two comparables were described as being located on the same block as the subject. The comparables are improved with 1-story dwellings of frame construction. The dwellings are from 53 to 59 years old and contain from 1,148 to 1,483 square feet of living area. Each comparable has a full unfinished basement and a 1-car garage. One comparable has central air conditioning, and two comparables have a fireplace. The board of review's comparable properties have improvement assessments ranging from \$9,758 to \$13,252 or from \$8.50 to \$10.50 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

## **Conclusion of Law**

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The Board finds the parties presented assessment data on a total of eight suggested comparables. The appellant's comparables received reduced weight in the Board's analysis due to differences in age (#1, #2 and #4), location (#2 and #4) and living area (#3 and #4). Board of review comparable #2 also had significantly more living area than the subject and likewise received reduced weight. The Board finds the best evidence of assessment equity to be board of review comparables #1, #3 and #4. Although these comparables differed from the subject in foundation, they were still very similar to the subject in location, one-story design, frame construction, age and living area. Board of review comparables #1, #2 and #4 had improvement assessments that ranged from \$9,758 to \$13,132 or from \$8.50 to \$10.50 per square foot of living area. The subject's improvement assessment of \$6,030 or \$5.00 per square foot of living area falls below the range established by the best comparables in this record. The Board considered adjustments and differences in the comparables when compared to the subject. Board of review comparables #1, #3 and #4 had full unfinished basements, while the subject had a slab foundation. The

superior attribute of a basement helps to explain why these comparables had higher improvement assessments than the subject. Based on this record, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

### **IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND</u> <u>EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
