



**FINAL ADMINISTRATIVE DECISION  
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Patrice Granity

The parties of record before the Property Tax Appeal Board are Patrice Granity, the appellant, by attorney John S. Xydakis, of the Law Offices of John S. Xydakis in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$2,573  
**IMPR.:** \$26,974  
**TOTAL:** \$29,547

Subject only to the State multiplier as applicable.

**Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2016 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

**Findings of Fact**

The subject property consists of a two-story dwelling of frame construction. The dwelling is a townhouse that is 28 years old and has 1,477 square feet of living area. Features of the home include a concrete slab foundation, central air conditioning, a fireplace and a two-car garage. The property has a 4,476 square-foot site and is located in Palatine, Palatine Township, Cook County. The subject is classified as a class 2-95 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity as the basis of the appeal. The subject's land assessment is not being contested in this appeal. In support of the inequity argument, the appellant submitted a grid analysis with information on four equity comparables and a spreadsheet with limited information on three additional equity comparables. On the grid analysis, four comparables are described as two-story dwellings of frame and masonry

construction that are 37 years old. Three comparables had no detailed description provided other than classification and neighborhood codes, size, and improvement assessment. The seven comparable dwellings range in size from 1,544 to 1,582 square feet of living area and have improvement assessments ranging from \$21,461 to \$22,576 or from \$13.86 to \$14.58 per square foot of living area. The appellant also submitted a map which revealed the seven comparables were located within a half-mile from the subject property. Based on this evidence, the appellant requested a reduction in the subject's improvement assessment to \$21,032 or \$14.24 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" wherein the subject's final assessment of \$29,547 was disclosed. The subject property has an improvement assessment of \$26,974 or \$18.26 per square foot of living area. The board of review presented descriptions and assessment information on four comparable properties. The comparables have the same neighborhood and classification codes as the subject and were described as being located on the same block as the subject property. The comparables are improved with two-story dwellings of frame construction. The dwellings are 28 years old and contain 1,477 or 1,481 square feet of living area. Each comparable has a partial finished basement, central air conditioning, a fireplace, and a two-car garage. The comparable properties have improvement assessments ranging from \$27,864 to \$28,215 or from \$18.87 to \$19.05 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

### **Conclusion of Law**

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties presented assessment data on a total of 11 suggested comparables. The Board finds the appellant's comparables #1 through #4 were somewhat older and larger than the subject. The Board finds the appellant did not provide enough descriptive information regarding comparables #5 through #7 to indicate whether they were similar to the subject property. As a result, all of the appellant's comparables received less weight in the Board's analysis.

The Board finds the best evidence of assessment equity to be the comparables submitted by the board of review. Although the board of review comparables had partial finished basements that were dissimilar from the subject's concrete slab foundation, the Board finds the board of review comparables were very similar to the subject in location, story height, frame construction, age, living area and other features. The board of review comparables had improvement assessments that ranged from \$27,869 to \$28,215 or from \$18.87 to \$19.05 per square foot of living area. The subject's improvement assessment of \$26,974 or \$18.26 per square foot of living area falls below the range established by the best comparables in this record. The Board considered adjustments and differences in the comparables when compared to the subject. The comparables

submitted by the board of review had partial finished basements, while the subject had a concrete slab foundation. The superior attribute of a partial finished basement helps to explain why the board of review comparables had higher improvement assessments than the subject. Based on this record, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

**IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
