

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Richard Henry, the appellant, by attorney Scott L. David, of Much Shelist in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$11,520 **IMPR.:** \$48,644 **TOTAL:** \$60,164

Subject only to the State multiplier as applicable.

# **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2016 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

# **Findings of Fact**

The subject property consists of a two-story dwelling of frame construction. The dwelling is approximately 101 years old and has 1,967 square feet of living area. Features of the home include a full unfinished basement, central air conditioning, a fireplace and a 1-car garage. The property has a 6,400 square-foot site and is located in Wilmette, New Trier Township, Cook County. The subject is classified as a class 2-05 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity as the basis of the appeal. In support of this argument, the appellant submitted information on four equity comparables with the same neighborhood and classification codes as the subject. One of the comparables is located on the same block as the subject. The comparables are improved with two-story dwellings of frame, masonry or stucco construction. The dwellings are from 90 to 118 years old and contain from 1,791 to 2,190 square feet of living area. The comparables have full or partial unfinished

basements and garages, either 1½-car or 2-car. Two comparables have central air conditioning, and three comparables have a fireplace. The comparables have improvement assessments that range from \$27,000 to \$45,852 or from \$12.33 to \$22.45 per square foot of living area. Based on this evidence, the appellant requested a reduction in the subject's improvement assessment to \$37,137 or \$18.88 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" wherein the subject's final assessment of \$60,164 was disclosed. The subject property has an improvement assessment of \$48,644 or \$24.73 per square foot of living area. The board of review presented descriptions and assessment information on four comparable properties that have the same neighborhood and classification codes as the subject. The comparables were described as being located a quarter-mile from the subject property. The comparables are improved with two-story dwellings of frame construction. The dwellings are from 88 to 123 years old and contain from 1,852 to 2,154 square feet of living area. The comparables have full basements, one of which has finished area. Three comparables have central air conditioning. Each comparable has a fireplace and a 2-car garage. The comparable properties have improvement assessments that range from \$47,777 to \$59,616 or from \$25.80 to \$29.18 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

# **Conclusion of Law**

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties presented assessment data on a total of eight suggested comparables. The Board finds the appellant's comparables #1 and #2 and board of review comparable #3 did not have central air conditioning and received reduced weight in the Board's analysis. The Board finds the best evidence of assessment equity to be the appellant's comparables #3 and #4 and board of review comparables #1, #2 and #4. The Board finds these comparables have central air conditioning like the subject and are also similar in location, two-story design, age, living area and foundation. These comparables have improvement assessments that range from \$43,373 to \$56,738 or from \$21.55 to \$29.18 per square foot of living area. The subject's improvement assessment of \$48,644 or \$24.73 per square foot of living area falls within the range established by the best comparables in this record. After considering adjustments to the comparables for differences from the subject, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

Date:

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
