

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Steven Pierce, the appellant, by attorney John S. Xydakis, of the Law Offices of John S. Xydakis in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$7,002 **IMPR.:** \$20,455 **TOTAL:** \$27,457

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2016 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a one-story dwelling of frame and masonry construction. The dwelling is 60 years old and has 1,530 square feet of living area. Features of the home include a crawl-space foundation and a two-car garage. The property has a 9,035 square-foot site and is located in Glenview, Maine Township, Cook County. The subject is classified as a class 2-03 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity as the basis of the appeal. In support of this argument, the appellant submitted information on four equity comparables that have the same neighborhood and classification codes as the subject. The comparables are improved with one-story dwellings of frame or masonry construction. The dwellings are from 61 to 64 years old and contain from 1,300 to 1,679 square feet of living area. The comparables do not have basements. Two comparables have central air conditioning, and two have fireplaces. Information regarding garages was not provided on the grid analysis; however, the appellant's photographic evidence

revealed that each comparable has a garage. The appellant also submitted a map which revealed the comparables were located from 0.5 to 1.5 miles from the subject property. The comparables have improvement assessments that range from \$13,004 to \$16,359 or from \$9.65 to \$10.26 per square foot of living area. Based on this evidence, the appellant requested a reduction in the subject's improvement assessment to \$15,361 or \$10.04 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" wherein the subject's final assessment of \$27,457 was disclosed. The subject property has an improvement assessment of \$20,455 or \$13.37 per square foot of living area. The board of review presented descriptions and assessment information on four comparable properties. The comparables have the same neighborhood and classification codes as the subject and were described as being located either on the same block or a quarter-mile from the subject property. The comparables are improved with one-story dwellings of frame and masonry construction. The dwellings are 59 or 60 years old and contain from 1,492 to 1,563 square feet of living area. Three comparables have crawl-space foundations, and one has a partial unfinished basement. One comparable has central air conditioning, and two comparables have fireplaces. Each comparable has a garage, either two-car or two and one-half car. The comparable properties have improvement assessments that range from \$20,142 to \$21,511 or from \$13.45 to \$14.34 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The Board finds the parties presented assessment data on a total of eight suggested comparables. The appellant's map revealed the appellant's comparables are not located near the subject. In addition, board of review comparable #3 has a partial unfinished basement that is dissimilar from the subject's crawl-space foundation. As a result, the appellant's comparables and board of review comparable #3 received reduced weight in the Board's analysis. The Board finds the best evidence of assessment equity to be board of review comparables #1, #2 and #4. The Board finds these comparables have crawl-space foundations like the subject; are located in close proximity to the subject; and are also very similar in story height, frame and masonry construction, age and living area. These three comparables have improvement assessments that range from \$20,142 to \$21,511 or from \$13.50 to \$14.34 per square foot of living area. The subject's improvement assessment of \$20,455 or \$13.37 per square foot of living area falls below the range established on a per square foot basis by the best comparables in this record. After considering adjustments to the comparables for differences from the subject, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

Date:

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
