

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are David Weaver, the appellant, by attorney John S. Xydakis, of the Law Offices of John S. Xydakis in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$4,950 **IMPR.:** \$32,729 **TOTAL:** \$37,679

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2016 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a two-story dwelling of frame construction. The dwelling is approximately 88 years old and has 1,904 square feet of living area. Features of the home include a full finished basement, central air conditioning, a fireplace and a two-car garage. The property has a 6,600 square-foot site and is located in Western Springs, Proviso Township, Cook County. The subject is classified as a class 2-05 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity as the basis of the appeal. In support of this argument, the appellant submitted a grid analysis with information on four equity comparables and a spreadsheet with limited information on three additional equity comparables. On the grid analysis, four comparables are described as two-story dwellings of frame construction that range in age from 91 to 121 years old. Three comparables had no detailed description provided other

than classification and neighborhood codes, size, and improvement assessment. The seven comparable dwellings range in size from 1,652 to 2,007 square feet of living area and have improvement assessments ranging from \$22,748 to \$27,850 or from \$12.76 to \$14.43 per square foot of living area. The appellant also submitted a map which revealed all seven comparables were located over one mile from the subject property in a different municipality. Based on this evidence, the appellant requested a reduction in the subject's improvement assessment to \$26,218 or \$13.77 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" wherein the subject's final assessment of \$37,679 was disclosed. The subject property has an improvement assessment of \$32,729 or \$17.19 per square foot of living area. The board of review presented descriptions and assessment information on four comparable properties with the same neighborhood and classification codes as the subject. The comparables were described as being located in close proximity to the subject property. The comparables are improved with 2-story dwellings of masonry, frame and masonry or stucco construction. The dwellings are from 84 to 88 years old and contain from 1,248 to 1,720 square feet of living area. Each comparable has a full unfinished basement, a fireplace, and a garage. One comparable has central air conditioning. The board of review's comparable properties have improvement assessments ranging from \$24,816 to \$34,604 or from \$18.80 to \$21.35 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties presented assessment data on a total of 11 suggested comparables. The Board finds the appellant did not provide enough descriptive information for comparables #5 through #7 to indicate whether they were actually comparable to the subject property. In addition, the Board finds the appellant's map indicates that all seven comparables differed significantly from the subject in location. As a result, the appellant's comparables received reduced weight in the Board's analysis. Board of review comparables #2 and #3 had significantly less living area than the subject and also received less weight. The Board finds the best evidence of assessment equity to be board of review comparables #1 and #4. The Board finds these comparables, despite having less living area than the subject, were very similar in location, story height, age and foundation. Board of review comparables #1 and #4 had improvement assessments of \$20.12 and \$19.13 per square foot of living area, respectively. The subject's improvement assessment of \$17.19 per square foot of living area falls below the improvement assessments of the best comparables in this record. Based on this record, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
