

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Kevin Huntley, the appellant, by attorney Robert Rosenfeld, of Robert H. Rosenfeld and Associates, LLC in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$9,943 **IMPR.:** \$14,314 **TOTAL:** \$24,257

Subject only to the State multiplier as applicable.

### **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2016 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

#### **Findings of Fact**

The subject property consists of a 1.5-story dwelling of frame exterior construction with 720 square feet of living area. The dwelling is approximately 87 years old. Features of the home include a full basement with a finished area and a 2-car garage. The property has a 9,250 square foot site and is located in Glenview, Northfield Township, Cook County. The subject is classified as a class 2-02 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends improvement assessment inequity as the basis of the appeal. In support of this argument, the appellant submitted information on three equity comparables that were located in the same neighborhood code as the subject property. The comparables are improved with 1-story dwellings of frame exterior construction ranging in size from 709 to 984 square feet of living area. The comparables range in age from 67 to 101 years old. Each comparable has a

partial or a full unfinished basement and a 1-car garage. The comparables have improvement assessments ranging from \$10,662 to \$15,704 or from \$13.26 to \$15.96 per square foot of living area. Based on this evidence, the appellant requested that the improvement assessment be reduced to \$10,620 or \$14.75 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$24,257. The subject property has an improvement assessment of \$14,314 or \$19.88 per square foot of living area. In support of its contention of the correct assessment, the board of review submitted information on four equity comparables located in the same neighborhood code as the subject property. Two comparables are located on the same block and two comparables are within .25 mile of the subject. The comparables are improved with 1-story or 1.5-story dwellings of frame or frame and masonry exterior construction ranging in size from 836 to 966 square feet of living area. The comparables range in age from 65 to 76 years old. Each comparable has a partial or a full unfinished basement and a 1-car or a 1.5-car garage. The comparables have improvement assessments ranging from \$28,343 to \$30,864 or from \$21.70 to \$24.96 per square foot of living area. Based on this evidence, the board of review requested the assessment be confirmed.

# **Conclusion of Law**

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted a total of seven suggested comparables for the Board's consideration. The Board initially finds the parties' comparables were all located within the same neighborhood code as the subject and had similar features when compared to the subject. However, six of the parties' comparables were of dissimilar 1-story homes, when compared to the subject's 1.5-story design. In determining the most similar comparables, even given their different designs, the Board gave less weight to the appellant's comparables #1 and #3, as well as the board of review's comparables #3 and #4, due to their considerably larger dwelling sizes when compared to the subject. The board finds the remaining comparables were similar to the subject in location, size, age, and features. These comparables have improvement assessments ranging from \$10,662 to \$20,120 or from \$15.04 to \$23.67 per square foot of living area. The subject's improvement assessment of \$14,314 or \$19.88 per square foot of living area falls within the range established by the similar comparables in this record. The Board further finds that the board of review's comparable #1 was the most similar comparable in this record, as it was the only 1.5-story dwelling submitted by the parties. This most similar comparable has an improvement assessment of \$20,120 or \$23.67 per square foot of living area, which further supports the subject's improvement assessment. Based on this record, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

Date:

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
