

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Jonas Sutrinaitis DOCKET NO.: 16-36898.001-R-1 PARCEL NO.: 03-35-412-010-0000

The parties of record before the Property Tax Appeal Board are Jonas Sutrinaitis, the appellant, by attorney George N. Reveliotis, of Reveliotis Law, P.C. in Park Ridge; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$5,200 **IMPR.:** \$18,849 **TOTAL:** \$24,049

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2016 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a multi-level, single-family dwelling with 1,193 square feet of living area and masonry exterior construction. Features of the home include a partial basement and a two-car garage. The property has a 10,400 square foot site and is located in Wheeling Township, Cook County. The subject is classified as a class 2-34, residential property under the Cook County Real Property Assessment Classification Ordinance.

The appellant raised two issues: an overvaluation and inequity arguments as the bases of the appeal. In support of both arguments, the appellant submitted information on four comparables. They are improved with a single-family dwelling of frame and masonry or masonry construction. The improvements ranged in size from 1,357 to 1,754 square feet of living area and in

improvement assessments from \$12.94 to \$16.90 per square foot. The properties sold from June, 2014 to November, 2016 for prices that ranged from \$152.38 to \$184.42 per square foot. Amenities included: a partial basement and a one-car or two-car garage.

Further, the appellant submitted copies of website printouts of the sale's deed and/or from the Cook County Recorder of Deeds office relating to each sales' details.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$24,049. The subject's assessment reflects a market value of \$240,490 or \$201.58 per square foot of living area, including land, when applying the level of assessment for class 2 property under the Cook County Real Property Assessment Classification Ordinance of 10%.

In addition, the board of review submitted two grid sheets: one with equity data & sales data on four properties and a second with equity data on four properties, but only sales data on two properties. Therefore, as to the overvaluation argument, there was descriptive, assessment, and sales data on five comparables, with one property repeated on both grid sheets. They are improved with a multi-level, frame, masonry or frame and masonry, single-family dwelling. The improvements ranged: in age from 49 to 56 years; in size from 1,103 to 1,193 square feet of living area; and in improvement assessments from \$17.00 to \$25.50 per square foot. They sold from April, 2015, to September, 2016, for prices that ranged from \$249.37 to \$300.35 per square foot.

As to the inequity argument, the board of review submitted descriptive and assessment data on a total of seven comparables. They are improved with a multi-level, masonry, frame or frame and masonry, single-family dwelling. The improvements ranged: in age from 49 to 56 years; in size from 1,103 to 1,244 square feet of living area; and in assessments from \$16.75 to \$25.50 per square foot of living area.

The appellant submitted no rebuttal evidence.

Conclusion of Law

Initially the appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The Board finds the best evidence of market value to be the board of review's comparable sales #3 and #4 from the sales grid as well as comparable sale #3 from the equity grid. These comparables sold for prices ranging from \$249.37 to \$276.07 per square foot of living area, including land. The subject's assessment reflects a market value of \$201.58 per square foot of

living area, including land, which is below the range established by the best comparable sales in this record. After making adjustments to the comparables for pertinent factors including; but limited to, time of sale, style, age and/or size, the Board finds a reduction in the subject's assessment is not justified.

Next, the taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The Board finds the best evidence of assessment equity to be *the board of review's comparables* #2, #3 and #4. These comparables had improvement sizes that ranged from 1,193 to 1,244 square feet and improvement assessments that ranged from \$16.75 to \$17.00 per square foot of living area. The subject's improvement assessment of \$15.80 per square foot of living area falls below the range established by the best comparables in this record. Based on this record, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
