**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

The parties of record before the Property Tax Appeal Board are Fausto Natali, the appellant(s); and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$54,745
IMPR.: \$2,005
TOTAL: \$56,750

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2016 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject consists of a three-story, masonry dwelling with 6,644 square feet of living area. The dwelling is 35 years old. The property has a 3,085 square foot site, and is located in Northfield Township, Cook County. The subject is classified as a class 2-11 property under the Cook County Real Property Assessment Classification Ordinance. The subject is not owner occupied.

The appellant contends assessment inequity as the basis of the appeal. In support of this argument the appellant submitted information on four equity comparables. The comparables are located on the same block as the subject property and are similar in size and amenities.

The board of review submitted its "Board of Review-Notes on Appeal" disclosing the total assessment for the subject of \$56,750. The subject property has an improvement assessment of \$54,745 or \$8.24 per square foot of living area. In support of its contention of the correct assessment, the board of review submitted information on four equity comparables. The

comparables are located on the same block as the subject property and are similar in size and amenities. The board of review's comparable #2 is identical to the appellant's comparable #3.

At hearing, the appellant testified that his comparables were located in the same complex as the subject property. He submitted a Property Tax Appeal Board decision identified by docket #16-38760.001-R-1 wherein he received an assessment reduction on a similar property with a similar fact pattern. The Property Tax Appeal Board took judicial notice of this decision.

The board of review rested on their written submission. The appellant then distinguished the board of review's comparables from the subject property.

Following the hearing, the appellant dropped off additional evidence at the Board's Des Plaines office. Appellant was not given leave to submit additional evidence at hearing. The Official Rules of the Property Tax Appeal Board prohibit the submission of new hearing evidence without the Hearing Officer's order, therefore, the additional evidence cannot be considered by the Board. 86 Ill.Admin.Code 1910.67(k).

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The Board finds the best evidence of assessment equity to be the appellant's equity comparables #1 through #4, as well as comparables #2 through #4 submitted by the board of review, as they are most similar to the subject in size, design, location, and amenities. These comparables had improvement assessments that ranged from \$7.05 to \$10.22 per square foot of living area. The subject's improvement assessment of \$8.24 per square foot of living area falls within the range established by the best comparables in this record. Based on this record the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.


