

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Janet Plumeri DOCKET NO.: 17-02059.001-R-1 PARCEL NO.: 09-25-209-076

The parties of record before the Property Tax Appeal Board are Janet Plumeri, the appellant, by attorney Ronald Kingsley, of Lake County Real Estate Tax Appeal, LLC in Lake Forest, and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>no change</u> in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$9,819 **IMPR.:** \$50,508 **TOTAL:** \$60,327

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2017 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a two-story townhome of wood siding exterior construction with 1,475 square feet of living area. The townhouse was constructed in 1989. Features include central air conditioning, a fireplace and an attached 380 square foot garage. The property is located in Wauconda, Wauconda Township, Lake County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument, the appellant submitted information on six comparable sales located in close proximity to the subject and within the same neighborhood code assigned by the assessor as the subject property. The comparables are improved with two-story townhomes of wood siding exterior construction that each contain 1,475 square feet of living area. The townhouses were constructed from 1988 to 1991. Three of the comparables feature full basements, two of which have finished areas. Each comparable has central air conditioning and an attached 380 square foot garage. Five of the

townhomes each feature a fireplace. The comparables sold from June 2015 to March 2017 for prices ranging from \$150,000 to \$185,000 or from \$101.69 to \$125.42 per square foot of living area, including land. Based on this evidence, the appellant requested a reduction in the subject's assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$60,327. The subject's assessment reflects a market value of \$181,982 or \$123.38 per square foot of living area, land included, when using the 2017 three year average median level of assessment for Lake County of 33.15% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment, the board of review submitted information on three comparable sales located in close proximity to the subject and within the same neighborhood code assigned by the assessor as the subject property. The comparables are improved with two-story townhomes of wood siding exterior construction that each contain 1,475 square feet of living area. The townhouses were constructed in 1989 and 1992. Each comparable features a full finished basement, central air conditioning, a fireplace and a 380 square foot garage. The comparables sold from March to July 2016 for prices ranging from \$199,000 to \$332,500 or from \$134.92 to \$225.42 per square foot of living area, including land. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted a total of nine comparable sales to support their respective positions before the Property Tax Appeal Board. The Board has given reduced weight to appellants' comparables #4, #5 and #6 and the board of review comparables due to their superior basement foundations as compared to the subject's lack of a basement.

The Board finds the best evidence of market value to be appellant's comparable sales #1, #2 and #3 which are each similar to the subject in location, design, exterior construction, size, age, foundation and most features. These most similar comparables sold from September 2016 to March 2017 for prices ranging from \$176,501 to \$182,000 or from \$119.66 to \$123.39 per square foot of living area, including land. The subject's assessment reflects a market value of \$181,982 or \$123.38 per square foot of living area, including land, which is within the range established by the best comparable sales in this record and supported given the similarities of these comparables to the subject. Based on this evidence, the Board finds a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
