

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are R. H. Bailin, the appellant, by attorney Ronald Kingsley of Lake County Real Estate Tax Appeal, LLC in Lake Forest; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>no change</u> in the assessment of the property as established by the Lake County Board of Review is warranted. The correct assessed valuation of the property is:

LAND:	\$44,058
IMPR.:	\$59,899
TOTAL:	\$103,957

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2017 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a one-story dwelling of wood siding exterior construction with 1,152 square feet of living area. The dwelling was constructed in 1947. Features of the home include a full unfinished basement, central air conditioning and a 480 square foot garage. The property is located in Deerfield, West Deerfield Township, Lake County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument, the appellant submitted information on four comparable sales located between .40 and .84 of a mile of the subject property. The comparables consist of one-story dwellings of brick or wood siding exterior construction ranging in size from 1,028 to 1,344 square feet of living area. The dwellings were constructed from 1951 to 1961. Each comparable has a basement, with one having finished area. The comparables each have central air conditioning and a garage ranging in size from 270 to 480 square feet of building area. Two comparables each have one fireplace.

The comparables sold from June 2016 to April 2017 for prices ranging from \$275,000 to \$305,000 or from \$226.19 to \$267.51 per square foot of living area, including land. Based on this evidence, the appellant requested a reduction in the subject's assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$103,957. The subject's assessment reflects a market value of \$313,596 or \$272.22 per square foot of living area, land included, when using the 2017 three-year average median level of assessment for Lake County of 33.15% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment, the board of review submitted information on four comparable sales located between .049 and .188 of a mile of the subject property. The comparables were improved with one-story dwellings of brick or wood siding exterior construction ranging in size from 1,064 to 1,260 square feet of living area. The dwellings were constructed from 1951 to 1959. Three comparables each feature a basement, with one having finished area. Three comparables have central air conditioning, two comparables each have one fireplace and each comparable has a garage ranging in size from 264 to 396 square feet of building area. The comparables sold from January 2015 to May 2017 for prices ranging from \$290,000 to \$387,000 or from \$265.87 to \$323.31 per square foot of living area, including land. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and no reduction in the subject's assessment is warranted.

The parties submitted eight suggested comparable sales for the Board's consideration. The Board finds board of review comparables #2 and #4 have sale dates in 2015, which are dated and less likely to be indicative of the subject's market value as of the January 1, 2017 assessment date.

The Board finds the best evidence of market value to be the four comparables submitted by the appellant, along with comparables #1 and #3 submitted by the board of review. These six comparables are similar to the subject in location, dwelling size, design and age. The comparables sold from June 2016 to May 2017 for prices ranging from \$275,000 to \$387,000 or from \$226.19 to \$323.31 per square foot of living area, including land. The subject's assessment reflects a market value of \$313,596 or \$272.22 per square foot of living area, land included, which falls within the range established by the best comparable sales in the record. The Board recognizes board of review comparable #3 lacks a basement, unlike the subject, however, its sale price in October 2016 for a price of \$335,000 or \$265.87 per square foot of living area, including land, supports the subject's assessment. After considering any necessary adjustments to the comparables for differences when compared to the subject, the Board finds the estimated market

value as reflected by the assessment is supported and no reduction in the subject's assessment is warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND</u> <u>EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
