

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Parimala Somasundaram

DOCKET NO.: 17-02486.001-R-1 PARCEL NO.: 15-20-101-008

The parties of record before the Property Tax Appeal Board are Parimala Somasundaram, the appellant, by attorney Ronald Kingsley, of Lake County Real Estate Tax Appeal, LLC in Lake Forest; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$48,161 **IMPR.:** \$145,153 **TOTAL:** \$193,314

Subject only to the State multiplier as applicable.

#### **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2017 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

#### **Findings of Fact**

The subject property consists of a two-story dwelling of brick exterior construction with 3,221 square feet of living area. The dwelling was constructed in 1984. Features of the home include a partial basement with finished area, central air conditioning, one fireplace and a 650 square foot attached garage. The property has a 43,996 square foot site and is located in Long Grove, Vernon Township, Lake County.

The appellant submitted evidence before the Property Tax Appeal Board claiming overvaluation as the basis of the appeal. In support of this argument, the appellant submitted information on six comparable sales located from .22 of a mile to 1.31 miles from the subject. The comparables are situated on sites ranging in size from 43,560 to 46,609 square feet of land area and are improved with one, one and one-half story dwelling and five, two-story dwellings of wood siding or brick exterior construction that were built from 1985 to 1988. The dwellings range in size

from 2,904 or 3,352 square feet of living area. Each comparable has a partial or a full basement with two having finished area and central air conditioning; five comparables each have one or two fireplaces; and each comparable has a garage range in size from 483 to 851 square feet of building area. Comparable #5 has a 621 square foot inground swimming pool. The comparables sold from April 2015 to April 2017 for prices ranging from \$427,500 to \$563,000 or from \$147.21 to \$180.97 per square foot of living area, including land. Based on this evidence, the appellant requested a reduction in the subject's assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$193,314. The subject's assessment reflects an estimated market value of \$583,149 or \$181.05 per square foot of living area, including land, when applying the 2017 three-year average median level of assessment for Lake County of 33.15%.

In support of the subject's assessment, the board of review submitted information on four comparable sales located within .47 of a mile from the subject. The comparables are situated on sites ranging in size from 43,631 to 52,054 square feet of land area and are improved with two-story dwellings of wood siding exterior construction that were built in 1985 or 1989. The dwellings range in size from 2,856 to 3,296 square feet of living area. The comparables each have a partial or a full basement with three having finished area, central air conditioning, one fireplace and a garage that ranges in size from 726 to 866 square feet of building area. The comparables sold from July 2016 to August 2018 for prices ranging from \$590,000 to \$620,000 or from \$182.04 to \$213.72 per square foot of living area, including land. Based on this evidence, the board of review requested confirmation of the subject's assessment.

## **Conclusion of Law**

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and no reduction in the subject's assessment is warranted.

The parties submitted ten comparable sales for the Board's consideration. The Board gave less weight to the appellant's comparables #1, #3, #4, #5 and #6 due to their unfinished basements or inground swimming pool in contrast to the subject's partially finished basement and lack of an inground swimming pool. The Board also gave less weight to the appellant's comparables #2, #4 and #6 along with board of review comparables #2 and #4 as they sold in 2015 and 2018, not as proximate in time to the January 1, 2017 assessment date as other sales in the record.

The Board finds the best evidence of the subject's market value to be the board of review comparables #1 and #3. These comparables are also similar to the subject in location, design, dwelling size, age and features. The comparables sold in July 2016 and January 2017 for prices of \$590,000 and \$620,000 or for \$206.58 to \$213.72 per square foot of living area, including land. The subject's assessment reflects an estimated market value of \$583,149 or \$181.05 per square foot of living area including land, which is supported by the best comparables sales in the record. After considering adjustments to the comparables for differences when compared to the

subject, the Board finds the subject's estimated market value as reflected by its assessment is supported and therefore, a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

### **IMPORTANT NOTICE**

Date:

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
