

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Carl Stevens, the appellant, by attorney Robert Rosenfeld, of Robert H. Rosenfeld and Associates, LLC in Chicago; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>No Change</u> in the assessment of the property as established by the Lake County Board of Review is warranted. The correct assessed valuation of the property is:

LAND:	\$88,713
IMPR.:	\$171,280
TOTAL:	\$259,993

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2017 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a two-story dwelling of brick exterior with 3,135 square feet of living area. The dwelling was constructed in 1966. Features of the home include a basement with 52 square feet of finished area, central air conditioning, two fireplaces and an attached 576 square foot garage. No site size was provided for the subject, which is located in Lake Forest, West Deerfield Township, Lake County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument the appellant submitted information on three comparable sales all located in the subject's neighborhood and within 0.56 mile of the subject property. No site sizes were provided for comparable sales. All of the comparable sites are improved with two-story dwellings ranging in size from 3,148 to 3,328 square feet of living area. The homes were built between 1956 and 1966. All comparables have basements, one with finished area, central air conditioning, one or

three fireplaces and garages ranging in size from 529 to 550 square feet of building area. The comparables sold from February 2016 to November 2016 for prices ranging from \$635,000 to \$672,500 or from \$190.81 to \$213.63 per square foot living area, land included. Based on this evidence, the appellant requested the subject's assessment be reduced to \$211,023.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$259,993. The subject's assessment reflects a market value of \$784,293 or \$250.17 per square foot of living area, land included, when using the 2017 three year average median level of assessment for Lake County of 33.15% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment the board of review submitted information on eight comparable sales all located in the subject's neighborhood and within 0.40 mile from the subject. No site sizes were provided for comparable sales. All of the comparable sites are improved with two-story dwellings ranging in size from 2,850 to 3,371 square feet of living area. The homes were built between 1960 and 1965. All comparables have basements, three with finished area, all have central air conditioning, one to three fireplaces and garages ranging in size from 480 to 632 square feet of building area. The comparables sold from June 2015 to March 2018 for prices ranging from \$750,000 to \$820,000 or from \$238.80 to \$287.11 per square foot living area, land included. Based on this evidence, the board of review requested the subject's assessment be confirmed.

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted a total of 11 comparable sales for the Board's consideration. The Board gives least weight to appellant's comparable #1 and board of review comparables #1, #2 and #8 as these comparables have finished basement area significantly larger than the subject. The Board also give minimal weight to the board of review's comparable #5 for a June 2015 sale date which is not as proximate in time to the assessment date as the best comparables found herein. The Board finds the best evidence of market value to be appellant's comparable sales #2 and #3 and the board of review comparable sales #2, #4, #6 and #7 which are considered to be most similar to the subject in location, basement feature, age and with sale dates considered relevant to a January 1, 2017 market valuation. These most similar comparables sold for prices ranging from \$635,000 to \$820,000 or from \$190.81 to 287.11 per square foot of living area, including land. The subject's assessment reflects a market value of \$784,293 or \$250.17 per square foot of living area, including land, which is within the range established by the best comparable sales in this record. Based on this evidence the Board finds a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND</u> <u>EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
