

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are James Hahn, the appellant, by attorney Robert Rosenfeld, of Robert H. Rosenfeld and Associates, LLC in Chicago; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>No Change</u> in the assessment of the property as established by the Lake County Board of Review is warranted. The correct assessed valuation of the property is:

LAND:	\$49,658
IMPR.:	\$139,979
TOTAL:	\$189,637

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2017 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a two-story dwelling of wood siding exterior construction with 3,768 square feet of living area. The dwelling was constructed in 1978. Features of the home include an unfinished full basement, central air conditioning, a fireplace, a 225 square foot enclosed porch and a 744 square foot attached garage. The property has a 52,518 square foot site and is located in Barrington, Ela Township, Lake County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument the appellant submitted information on three comparable sales located from 0.53 to 1.53 miles from the subject property. The comparable parcels range in size from 29,603 to 44,771 square feet of land area and are improved with two-story dwellings of brick exterior construction that range from 3,201 to 4,206 square feet of living area. The homes were built in 1976 or 1977. The comparables have unfinished basements, central air conditioning, one or two fireplaces and

attached garages that have 725 or 986 square feet of building area. The comparables sold from June 2016 to March 2017 for prices ranging from \$430,000 to \$545,000 or from \$129.58 to \$135.34 per square foot of living area, land included. Based on this evidence, the appellant requested the subject's assessment be reduced to \$167,152.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$189,637. The subject's assessment reflects a market value of \$572,057 or \$151.82 per square foot of living area, land included, when using the 2017 three year average median level of assessment for Lake County of 33.15% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment the board of review submitted information on four comparable sales located from 0.21 to 0.84 of a mile from the subject property. The comparable parcels range in size from 39,768 to 65,290 square feet of land area and are improved with two-story dwellings of wood siding exterior construction that range from 3,244 to 3,691 square feet of living area. The homes were built from 1980 to 1992. The comparables have basements, three with finished area;¹ central air conditioning; one or two fireplaces and a garage that range in size from 726 to 1,001 square feet of building area. One comparable has an inground swimming pool. The comparables sold from May 2016 to May 2017 for prices ranging from \$607,000 to \$850,000 or from \$165.94 to \$236.11 per square foot of living area, land included. Based on this evidence, the board of review requested the subject's assessment be confirmed.

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted seven comparables for the Board's consideration. The Board gives least weight to the appellant's comparables #1 and #2 based on distance greater than one mile from the subject and smaller site sizes. The Board gives little weight to the board of review comparable #2 which appears to be an outlier in terms of sale price and #4 which is significantly newer in age when compared to the subject. The Board finds the best evidence of market value to be appellant's comparable #3 and board of review comparables #1 and #3 which are more similar to the subject in location, site size and age. These most similar comparables sold from June 2016 to May 2017 for prices ranging from \$545,000 to \$625,000 or from \$129.58 to \$192.66 per square foot of living area, including land. The subject's assessment reflects a market value of \$572,057 or \$151.82 per square foot of living area, including land, which is within the range established by the best comparable sales in this record. After considering adjustments to comparables for differences to the subject, the Board finds a reduction in the subject's assessment is not justified.

¹ Basement finished area was obtained from property sketches provided by the board of review.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND</u> <u>EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
