

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Jay & Susan Goldstein DOCKET NO.: 17-03864.001-R-1 PARCEL NO.: 16-15-117-007

The parties of record before the Property Tax Appeal Board are Jay & Susan Goldstein, the appellants, by attorney Robert Rosenfeld of Robert H. Rosenfeld and Associates, LLC in Chicago; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>no change</u> in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$49,914 **IMPR.:** \$93,464 **TOTAL:** \$143,378

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellants timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2017 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property is improved with a two-story dwelling of brick construction with 2,284 square feet of living area. The dwelling was built in 1979. Features of the home include a partial unfinished basement, central air conditioning, one fireplace and an attached two-car garage with 504 square feet of building area. The property has a 7,885 square foot site and is located in Highland Park, Moraine Township, Lake County.

The appellants contend assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument the appellants submitted information on three equity comparables improved with two-story dwellings with wood siding or brick exteriors that range in size from 2,220 to 2,528 square feet of living area. The dwellings were built from 1956 to 1966. Each home has a basement with one being partially finished, central air conditioning, one fireplace and an attached garage ranging in size from 264 to 525 square feet of building area.

The comparables are located from .31 to .71 miles from the subject property. These properties have improvement assessments ranging from \$61,116 to \$82,293 or from \$25.52 to \$32.55 per square foot of living area. The appellants requested the subject's improvement assessment be reduced to \$68,893.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$143,378. The subject property has an improvement assessment of \$93,464 or \$40.92 per square foot of living area.

In support of its contention of the correct assessment the board of review submitted information on four equity comparables improved with two-story dwellings with brick exteriors ranging in size from 2,337 to 2,612 square feet of living area. The homes were built from 1956 to 1979. Three comparables have basements with one having finished area. Each property has central air conditioning, one fireplace and an attached garage ranging in size from 441 to 525 square feet of building area. The comparables are located from .011 to .328 miles from the subject property. The comparables have improvement assessments ranging from \$99,718 to \$104,176 or from \$39.42 to \$43.44 per square foot of living area.

The board of review requested the assessment be sustained.

Conclusion of Law

The appellants contend assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellants did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The Board finds the best evidence of assessment equity to be comparables #1, #3 and #4 submitted by the board of review as these comparables are most similar to the subject dwelling in age as well as being relatively similar in features with the exception each home is larger than the subject dwelling. These properties have improvement assessments ranging from \$99,718 to \$104,176 or from \$39.42 to \$40.19 per square foot of living area. The subject's improvement assessment of \$93,464 or \$40.92 per square foot of living area falls below the overall range but above the range on a square foot basis as established by the best comparables in this record, which is justified based on the differences in size and considering the economies of scale. Less weight is given the comparables provided by the appellants and board of review comparable #2 as they are less similar to the subject dwelling in age and board of review comparable #2 has no basement, unlike the subject property.

Based on this record the Board finds the appellants did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
