

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are PNC Bank, NA, the appellant, by attorney Dennis M. Nolan of Dennis M. Nolan, P.C. in Bartlett; the DuPage County Board of Review; and Hinsdale Twp. High School Dist. No. 86, intervenor, by attorney John M. Izzo of Hauser, Izzo, Petrarca, Gleason & Stillman, LLC in Flossmoor.

Prior to the hearing the appellant and the board of review reached an agreement as to the correct assessment of the subject property. Hinsdale Twp. High School Dist. No. 86 adopted the evidence submitted by the board of review. Pursuant to section 1910.99(a) of the rules of the Property Tax Appeal Board, due to Hinsdale Twp. High School Dist. No. 86 adopting the evidence of the board of review, the intervening school district is bound by the terms of the stipulation or agreement. (86 Ill.Admin.Code §1910.99(a)). This assessment agreement was presented to and considered by the Property Tax Appeal Board.

After reviewing the record and considering the evidence submitted, the Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of this **DuPage** County appeal. The Property Tax Appeal Board further finds that the agreement of the parties is proper, and the correct assessed valuation of the property is:

LAND:	\$382,980
IMPR.:	\$325,280
TOTAL:	\$708,260

Subject only to the State multiplier as applicable.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND</u> <u>EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
