

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Ben Plominski, the appellant, by Amy C. Floyd, Attorney at Law in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>No Change</u> in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

#### **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2017 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

#### **Findings of Fact**

The subject property consists of a two-story dwelling of frame construction with 2,230 square feet of living area. The dwelling is approximately 30 years old. Features of the home include a partial basement, central air conditioning, one fireplace and a three-car garage. The property has a 58,762 square foot site and is located in Inverness, Palatine Township, Cook County. The subject is classified as a class 2-78 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument, the appellant submitted information on four equity comparables located in the same neighborhood code as the subject property. The comparables are improved with two-story dwellings of frame, masonry or frame and masonry exterior construction ranging in size from 2,523 to 2,754 square feet of living area. The comparables range in age from 32 to 62 years old. Each comparable has a basement, three comparables have

central air conditioning and three comparables have at least one fireplace. The appellant's attorney did not provide any information on garages for the comparables. The comparables have improvement assessments ranging from \$37,099 to \$40,728 or from \$14.02 to \$14.85 per square foot of living area. Based on this evidence, the appellant requested that the improvement assessment be reduced to \$32,313 or \$14.49 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$46,769. The subject property has an improvement assessment of \$37,955 or \$17.02 per square foot of living area. In support of its contention of the correct assessment, the board of review submitted information on four equity comparables located in a different neighborhood code as the subject property. The comparables are improved with two-story dwellings of frame or frame and masonry exterior construction ranging in size from 2,145 to 2,399 square feet of living area. The comparables range in age from 26 to 28 years old. Three comparables have full basements and one comparable has a concrete slab foundation and each comparable has central air conditioning, one fireplace and a two-car or a three-car garage. The comparables have improvement assessments ranging from \$35,184 to \$41,723 or from \$16.40 to \$17.39 per square foot of living area. Based on this evidence, the board of review requested the assessment be confirmed.

## **Conclusion of Law**


The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted eight suggested comparables for the Board's consideration. The Board gave little weight to the board of review's comparables as they are located in a different neighborhood code from the subject.

The Board finds the best evidence of assessment equity is the appellant's comparables as they are similar to the subject in location, design, and features, although they have larger dwelling sizes and/or older ages when compared to the subject and would require upward adjustments for age. The appellant's comparables have improvement assessments ranging from \$14.02 to \$14.85 per square foot of living area. The subject's improvement assessment of \$17.02 per square foot of living area exceeds the range established by the appellant's comparables in this record; however, the assessment is supported. Accepted real estate valuation theory provides, all other factors being equal, as the size of a property increases, its per unit value decreases. Likewise, as the size of a property decreases, its per unit value increases. Based on this analysis, the Board finds the subject's higher per square foot improvement assessment is warranted. After considering adjustments to the comparables for differences when compared to the subject, the Board finds the subject's improvement assessment is supported and a reduction in the subject's assessment is not justified.

## **IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND</u> <u>EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
