



**FINAL ADMINISTRATIVE DECISION  
ILLINOIS PROPERTY TAX APPEAL BOARD**

The parties of record before the Property Tax Appeal Board are Mark Dawley, the appellant, by attorney Robert Rosenfeld, of Robert H. Rosenfeld and Associates, LLC in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

**Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2017 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

**Findings of Fact**

The subject property consists of three parcels. Parcel #1 has a two-story dwelling of frame exterior construction with 3,193 square feet of living area. The dwelling is approximately 4 years old. Features of the home include a full unfinished basement, central air conditioning, two fireplaces and a 2-car garage. Parcels #2 and #3 have land assessments with no improvement assessments to the properties. The subject's three parcels are located in Glencoe, New Trier Township, Cook County. The subject is classified as a class 2-78 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant submitted a copy of the final decision of the Cook County Board of Review dated December 2, 2017 for the 2017 assessment year concerning the three parcels which depicts assessments of \$112,803 for Parcel #1 (PIN 05-07-419-033-0000), \$489 for Parcel #2 (PIN 05-

07-419-035-0000) and \$4,164 for Parcel #3 (PIN 05-07-419-036-0000). The subject's three parcels have a combined total assessment of \$117,456. The attorney for the appellant submitted its "Residential Appeal" with a "Comparable Sales/Assessment Grid Analysis", "Addendum to Petition" showing a separate listing of each individual parcel's land and improvement assessments, and a supplemental "Brief" from the appellant's attorney depicting that the assessments for parcels #2 and #3 are not contested.

The appellant contends improvement assessment inequity as the basis of the appeal for Parcel #1 and did not contest the land assessments for either of the subject's three parcels. In support of this argument, the appellant submitted information on three equity comparables that are located within the same neighborhood code as the subject. The comparables are improved with two-story dwellings of frame or masonry exterior construction ranging in size from 3,319 to 3,539 square feet of living area. The dwellings are either 19 or 24 years old. Each comparable has a full basement with one having finished area. Each comparable has central air conditioning, one fireplace and a 2-car or a 3.5-car garage. The comparables have improvement assessments ranging from \$80,420 to \$83,448 or from \$23.58 to \$24.23 per square foot of living area. Based on this evidence, the appellant requested that the subject's improvement assessment for Parcel #1 be reduced to \$76,600 or \$23.99 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for Parcel #1 of \$112,803. Parcel #1 has an improvement assessment of \$93,906 or \$29.41 per square foot of living area. In support of its contention of the correct assessment the board of review submitted information on three equity comparables located in the same neighborhood code as the subject property. The comparables are improved with two-story dwellings of masonry or frame and masonry exterior construction ranging in size from 3,102 to 3,441 square feet of living area. The comparables range in age from 1 to 19 years old. Each comparable has a full basement with one having finished area. Each comparable has central air conditioning, one or two fireplaces and a 2-car garage. The comparables have improvement assessments ranging from \$96,875 to \$112,526 or from \$29.77 to \$34.53 per square foot of living area. Based on this evidence, the board of review requested the subject's assessment be confirmed.

### **Conclusion of Law**

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted six suggested comparables for the Board's consideration. The Board gave less weight to the appellant's comparable #3 and the board of review's comparable #3 due to their finished basement areas when compared to the subject.

The Board finds the best evidence of assessment equity to be the parties' remaining comparables as they are most similar to the subject in location, design, dwelling size, basement and most features, except three of these comparables have older ages than the subject requiring upward adjustments for age. These comparables have improvement assessments ranging from \$80,948 to \$112,526 or from \$23.58 to \$34.53 per square foot of living area. The subject's improvement assessment of \$93,906 or \$29.41 per square foot of living area falls within the range established by the best comparables in this record. After considering adjustments to the comparables for differences to the subject, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's improvement assessment based on inequity is not warranted.

The constitutional provision for uniformity of taxation and valuation does not require mathematical equality. A practical uniformity, rather than an absolute one, is the test. Apex Motor Fuel Co. v. Barrett, 20 Ill.2d 395 (1960). Although the comparables presented by the parties disclosed that the properties located in the same area are not assessed at identical levels, all that the constitution requires is a practical uniformity, which appears to exist on the basis of the evidence.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

**IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
