



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

The parties of record before the Property Tax Appeal Board are Eric Sigurdson, the appellant, by attorney Robert Rosenfeld, of Robert H. Rosenfeld and Associates, LLC in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$18,840
IMPR.: \$71,843
TOTAL: \$90,683

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2017 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property is improved with a two-story dwelling of frame and masonry exterior construction with 4,079 square feet of living area. The dwelling is approximately 88 years old and features a full unfinished basement, central air conditioning and a two-car garage. The subject is located in Glencoe, New Trier Township, Cook County. It is classified as a class 2-06 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity as the basis of the appeal. In support of this argument the appellant submitted information on three, class 2-06 comparables that are located within the same neighborhood code as the subject. The comparables range in age from 96 to 116 years old and range in size from 3,740 to 4,079 square feet of living area. Each comparable has a full basement with two having finished area. Two comparables each have central air conditioning, two fireplaces, and a two-car garage. The comparables have improvement

assessments ranging from \$58,066 to \$67,304 or from \$15.53 to \$16.50 per square foot of living area. Based on this evidence the appellant requested the subject's improvement assessment be reduced to \$64,856 or \$15.90 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$90,683. The subject property has an improvement assessment of \$71,843 or \$17.61 per square foot of living area. In support of its contention of the correct assessment, the board of review submitted information on three, class 2-06 comparables that are located within the same neighborhood code as the subject. The comparables range in size from 2,770 to 3,467 square feet of living area and range in age from 65 to 103 years old. Each comparable has a full basement with two having finished area, central air conditioning, one fireplace, and a two-car garage. The comparables have improvement assessments ranging from \$66,548 to \$74,749 or from \$21.56 to \$24.02 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The appellant contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted a total of six comparables for the Board's consideration. The Board gives less weight to the appellant's comparable #1 which is the only comparable in this record that lacks both central air conditioning and a garage when compared to the subject. The Board also gives less weight to the board of review comparables #1 and #2 due to their considerably smaller dwelling sizes in relation to the other comparables when compared to the subject.

The Board finds the best comparables in this record to be the appellant's comparables #2 and #3 as well as the board of review comparable #3. Despite some of the comparables varying dissimilarities to the subject with either their older age, smaller dwelling size, and/or finished basement, these comparables are most similar in overall property characteristics to the subject. The appellant's comparable #3 is also identical to the subject in dwelling size, except it is slightly older in age and has a finished basement, unlike the subject which has an unfinished basement. The comparables have improvement assessments ranging from \$59,884 to \$74,749 or from \$15.66 to \$21.56 per square foot of living area. The subject property has an improvement assessment of \$71,843 or \$17.61 per square foot of living area which falls within the range established by the three most similar comparables in the record. After considering adjustments to the comparables for differences to the subject, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement is inequitably assessed and a reduction in the subject's improvement assessment is not warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
