

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Kristin Hatch, the appellant, by attorney Scott L. David, of Much Shelist in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>no change</u> in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$3,060 **IMPR.:** \$18,207 **TOTAL:** \$21,267

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2017 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a two-story dwelling of frame construction with 2,014 square feet of living area. The dwelling is 62 years old. Features of the home include a full unfinished basement, a fireplace and a 2-car garage. The property has an 8,162 square foot site and is located in Tinley Park, Bremen Township, Cook County. The subject is classified as a class 2-78 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity with respect to the subject's improvement as the basis of the appeal. ¹ In support of this argument the appellant submitted information on four equity comparables that are located within the same neighborhood code as the subject. The comparables are 2-story dwellings of frame or frame and masonry construction that range in size

from 2,052 to 2,208 square feet of living area. The homes range in age from 54 to 61 years old. Three comparables have full unfinished basements and one comparable has a crawl-space foundation. Two comparables have central air conditioning and each comparable has either a 1-car or a 2-car garage. The comparables have improvement assessments ranging from \$18,058 to \$18,459 or from \$8.36 to \$8.80 per square foot of living area.

Based on this evidence the appellant requested that the subject's total assessment be reduced to \$20,401.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$21,267. The subject property has an improvement assessment of \$18,207 or \$9.04 per square foot of living area. In support of its contention of the correct assessment the board of review submitted information on three equity comparables that are located within the same neighborhood code as the subject. The comparables are 2-story dwellings of frame, masonry or frame and masonry construction that range in size from 2,093 to 2,567 square feet of living area. The homes range in age from 54 to 59 years old. One comparable has a full unfinished basement, one comparable has a finished partial basement and one comparable has a crawl-space foundation. One comparable has central air conditioning and each comparable has either a 2-car or a 2.5-car garage. The comparables have improvement assessments ranging from \$18,093 to \$22,367 or \$8.64 or \$8.71 per square foot of living area.

Based on this evidence the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The taxpayer contends improvement assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted a total of seven comparable properties for the Board's consideration. The Board finds all of the parties' comparables are similar to the subject in location, style, size, age and most features. However, two of the parties' comparables each have a dissimilar crawl-space foundation and all of the comparables are larger in size, when compared to the subject. Nevertheless, the comparables have improvement assessments ranging from \$18,058 to \$22,367 or from \$8.36 to \$8.80 per square foot of living area. The subject's improvement assessment of \$18,207 or \$9.04 per square foot of living area falls within the range established by the comparables in the record on a total improvement assessment basis but slightly above the range on a per square foot basis. However, after considering adjustments to the comparables for differences when compared to the subject, such as their larger sizes, the Board finds the subject's per square foot improvement assessment is supported. Accepted real estate valuation theory provides, all other factors being equal, as the size of a property increases, its per unit value

decreases. Likewise, as the size of a property decreases, its per unit value increases. Based on this analysis, the Board finds the subject's slightly higher per square foot improvement assessment is justified given its smaller size. Therefore, no reduction in the subject's improvement assessment is warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
