

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Robert Edmiston, the appellant(s), by attorney Herbert B. Rosenberg, of Schoenberg Finkel Beederman Bell Glazer, LLC in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$2,312 **IMPR.:** \$39,812 **TOTAL:** \$42,124

Subject only to the State multiplier as applicable.

#### **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2017 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

#### **Findings of Fact**

The subject property consists of a two-story dwelling of masonry construction with 4,050 square feet of living area. The dwelling is 39 years old. The property has a 2,569 square foot site located in Elk Grove Township, Cook County. The subject is classified as a class 2-11 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity as the basis of the appeal. In support of this argument the appellant submitted information on twelve equity comparables. The appellant stated the subject is one apartment building located in the Oak Terrace Apartment Complex. The appellant stated the Permanent Index Numbers ("PINs") within the Oak Terrace Apartment Complex are 08-23-201-044-0000 through 08-23-201-078-0000.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$42,124. The subject property has an improvement assessment of \$39,812 or \$9.83 per square foot of living area. In support of its contention of the correct assessment the board of review submitted two grid sheets containing four comparables each, for a total of eight comparables.

In written rebuttal, the appellant stated that the board of review's comparable properties #1, #2, and #3 on its first grid sheet are located within the subject apartment complex and therefore should not be considered pursuant to <u>Pace Realty Group Inc. v. Property Tax Appeal Bd.</u> 306 Ill.App.3d 718

### **Conclusion of Law**

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The Board agrees with the appellant's argument that board of review comparable properties #1, #2, and #3 listed on its first grid sheet should not be considered as they are located within the subject's apartment complex pursuant to Pace Realty Group Inc. v. Property Tax Appeal Bd. 306 Ill.App.3d 718 wherein the Illinois Appellate Court held that the Property Tax Appeal Board errs as a matter of law when it selects as a comparable a parcel of property located within the same complex as the subject property that received the same contested assessment of the subject. *Id*.

The Board finds the best evidence of assessment equity to be the appellant's comparable properties and the board of review's comparable propertiess, except #1, #2, and #3 listed on its first grid sheet. These comparables had improvement assessments that ranged from \$5.44 to \$11.25 per square foot of living area. The subject's improvement assessment of \$9.83 per square foot of living area falls within the range established by the best comparables in this record. Based on this record the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

# **IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
