

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Boris Nulman, the appellant, by attorney Robert Rosenfeld, of Robert H. Rosenfeld and Associates, LLC in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$36,466 **IMPR.:** \$87,612 **TOTAL:** \$124,078

Subject only to the State multiplier as applicable.

#### **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2017 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

#### **Findings of Fact**

The subject property consists of a two-story dwelling of masonry exterior construction with 5,144 square feet of living area. The dwelling is approximately 16 years old. Features of the home include a partial basement with finished area, central air conditioning, one fireplace and a three-car garage. The property has a 31,710 square foot site located in Northbrook, Northfield Township, Cook County. The subject is classified as a class 2-09 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument, the appellant submitted information on three equity comparables that are located within the same neighborhood code as the subject property. The comparables are improved with class 2-09 dwellings of masonry exterior construction ranging in size from 5,786 to 6,695 square feet of living area. The dwellings are either 12 or 22 years old.

The comparables have full basements, one of which has finished area. Each comparable has central air conditioning, two fireplaces and a three-car or a four-car garage. The comparables have improvement assessments ranging from \$76,138 to \$101,965 or from \$13.16 to \$15.23 per square foot of living area. Based on this evidence, the appellant requested that the subject's improvement assessment be reduced to \$72,016 or \$14.00 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" for parcel #04-08-405-007-0000 located at 2860 Hillcrest Ln., Northbrook, IL which is not the subject. However, the Board finds the four suggested equity comparables are located in the same neighborhood code as the subject and will consider them in this decision. The comparables are improved with two-story class 2-09 dwellings of masonry exterior construction ranging in size from 5,173 to 7,089 square feet of living area. The dwellings range in age from 10 to 25 years old. The comparables have partial or full basements, one of which has finished area. Each comparable has central air conditioning, one to three fireplaces and a three-car or a four-car garage. The comparables have improvement assessments ranging from \$88,096 to \$120,739 or from \$17.03 to \$19.25 per square foot of living area. Based on this evidence, the board of review requested the subject's assessment be confirmed.

The appellant's submission included a copy of the "Cook County Board of Review" final decision dated April 16, 2018 disclosing the subject has a total assessment of \$124,078. The appellant's petition also revealed that the subject has an improvement assessment of \$87,612 or \$17.03 per square foot of living area.

# **Conclusion of Law**

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted seven suggested comparables for the Board's consideration. The Board gives less weight to the appellant's comparables and the board of review's comparable #1 due to their larger dwelling sizes when compared to the subject.

The Board finds the best evidence of assessment equity to be the board of review's comparables #2, #3 and #4 as they are most similar to the subject in location, design, exterior construction, age, dwelling size, and some features, except two of these comparables have unfinished basements, in contrast to the subject, requiring upward adjustments to make them more equivalent to the subject. These comparables have improvement assessments ranging from \$88,096 to \$104,590 or from \$17.03 to \$19.25 per square foot of living area. The subject's improvement assessment of \$87,612 or \$17.03 per square foot of living area falls below the range established by the best comparables in this record on an overall improvement assessment basis and matches the comparable with the lowest improvement assessment on a per square foot

of living area basis. After considering adjustments to the comparables for differences from the subject, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's improvement assessment based on inequity is not warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

#### **IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
