

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT:Mary Ann Francisco M&H EnterprisesDOCKET NO.:17-40960.001-R-1PARCEL NO.:29-18-211-047-0000

The parties of record before the Property Tax Appeal Board are Mary Ann Francisco M&H Enterprises, the appellant(s), by attorney Jessica Hill-Magiera, Attorney at Law in Lake Zurich; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>*A Reduction*</u> in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND:	\$1,171
IMPR.:	\$1,169
TOTAL:	\$2,340

Subject only to the State multiplier as applicable.

#### **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2017 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

#### **Findings of Fact**

The subject property consists of a 63 year old, one-story, single-family dwelling of masonry construction with 975 square feet of living area. Features of the dwelling include a slab basement, one bath, and a two-car garage. The property has a 4,687 square foot site and is located in Harvey, Thornton Township, Cook County. The record does not disclose whether the subject was owner-occupied during the lien year. The subject is classified as a Class 2-02 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends overvaluation as the basis of the appeal. In support of this argument, the appellant submitted information on five suggested sale comparables. The appellant requested a total assessment reduction to \$909.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$4,195. The subject's assessment reflects a market value of \$41,950 or \$43.02 per square foot of living area including land, when applying the 2017 level of assessment of 10.00% for Class 2 property under the Cook County Real Property Assessment Classification Ordinance. In support of its contention of the correct assessment, the board of review submitted information on three suggested sale comparables.

In rebuttal, the appellant distinguished the board of review's comparables based on sale date, age, basement, and location. The appellant reaffirmed the request for an assessment reduction.

### **Conclusion of Law**

When overvaluation is claimed, the appellant has the burden of proving the value of the property by a preponderance of the evidence. <u>Cook Cnty. Bd. of Review v. Prop. Tax Appeal Bd.</u>, 339 III. App. 3d 529, 545 (1st Dist. 2002); <u>National City Bank of Michigan/Illinois v. Prop. Tax Appeal Bd.</u>, 331 III. App. 3d 1038, 1042 (3d Dist. 2002) (citing <u>Winnebago Cnty. Bd. of Review v. Prop. Tax Appeal Bd.</u>, 313 III. App. 3d 179 (2d Dist. 2000)); 86 III. Admin. Code § 1910.63(e). Proof of market value may consist of an appraisal, a recent arm's length sale of the subject property, recent sales of comparable properties, or recent construction costs of the subject property. <u>Calumet Transfer, LLC v. Prop. Tax Appeal Bd.</u>, 401 III. App. 3d 652, 655 (1st Dist. 2010); 86 III. Admin. Code § 1910.65(c). Having considered the evidence presented, the Board finds that the evidence indicates a reduction is warranted.

The Board finds the best evidence of market value to be the appellant's comparables. These comparables are similar in stories, size, location, and age. These comparables sold for prices ranging from \$7.50 to \$24.70 per square foot of living area, including land. The subject's assessment reflects a market value of \$43.03 per square foot of living area including land, which is above the range established by the best comparable sales in this record. Based on this evidence, the Board finds a reduction in the subject's assessment is justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

### **IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND</u> <u>EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
