



**FINAL ADMINISTRATIVE DECISION  
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Mihalis Vassos

The parties of record before the Property Tax Appeal Board are Mihalis Vassos, the appellant, by attorney George N. Reveliotis of Reveliotis Law, P.C. in Park Ridge; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **no change** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$4,274  
**IMPR.:** \$17,828  
**TOTAL:** \$22,102

Subject only to the State multiplier as applicable.

**Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2017 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

**Findings of Fact**

The subject property consists of a one-story dwelling of masonry exterior construction with 1,013 square feet of living area. The dwelling is approximately 62 years old. Features of the home include a full basement with finished area and a two-car garage. The property has a 5,896 square foot site and is located in Morton Grove, Niles Township, Cook County. The subject is classified as a class 2-03 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends overvaluation as the basis of the appeal. In support of this argument the appellant submitted information on four comparable sales located within the same neighborhood code as the subject property. The comparables have sites that range in size from 6,232 to 7,110 square feet of land area. The comparables are improved with similar class 2-03 dwellings of masonry or frame and masonry exterior construction that are each 62 years old with either 1,074

or 1,246 square feet of living area. Three comparables each have an unfinished partial basement and one comparable has a crawl space foundation. One comparable has central air conditioning and each comparable has either a 1-car or a 1.5-car garage. The properties sold from February 2015 to November 2017 for prices ranging from \$172,000 to \$217,000 or from \$160.15 to \$174.16 per square foot of living area, land included. Based on this evidence, the appellant requested the subject's assessment be reduced to \$17,104, reflecting a market value of \$171,040 or \$168.85 per square foot of living area, land included, when applying the level of assessment for class 2 property under the Cook County Real Property Assessment Classification Ordinance of 10%.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$22,102. The subject's assessment reflects a market value of \$221,020 or \$218.18 per square foot of living area, including land, when applying the level of assessment for class 2 property under the Cook County Real Property Assessment Classification Ordinance of 10%.

In support of its contention of the correct assessment the board of review submitted information on four comparable sales located within the same neighborhood code as the subject property and within .25 of a mile from the subject. The comparables have sites that range in size from 2,950 to 6,963 square feet of land area. The comparables are improved with similar class 2-03 one-story dwellings of masonry exterior construction ranging in size from 1,116 to 1,150 square feet of living area. The dwellings range in age from 48 to 62 years old. Each comparable has a full basement with one having finished area. One comparable has central air conditioning and three comparables each have either a one-car or a two-car garage. The properties sold from August 2015 to December 2016 for prices ranging from \$225,000 to \$332,000 or from \$196.68 to \$296.43 per square foot of living area, land included. Based on this evidence, the board of review requested confirmation of the subject's assessment.

### **Conclusion of Law**

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties provided eight suggested comparable sales for the Board's consideration. The Board gives less weight to the appellant's comparables #1 and #4 as comparable #1 has a larger dwelling when compared to the subject dwelling and comparable #4 has a crawl space foundation, unlike the subject's full finished basement. The Board gives reduced weight to board of review comparables #2 and #3 as each dwelling is newer than the subject dwelling.

The Board finds the best evidence of market value to be appellant's comparables #2 and #3, along with board of review comparables #1 and #4. These comparables are relatively similar to the subject in location, dwelling size, design and age, though they have features with varying degrees of similarity when compared to the subject. The comparables sold from February 2015

to October 2017 for prices ranging from \$172,000 to \$332,000 or from \$160.15 to \$296.43 per square foot of living area, including land. The subject's assessment reflects a market value of \$221,020 or \$218.18 per square foot of living area, including land, which is within the range established by best comparable sales in this record. After considering necessary adjustments to the comparables for differences when compared to the subject, the Board finds no reduction in the subject's estimated market value as reflected by its assessment is warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

**IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
