

## FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Beverly Feldmann, the appellant, by attorney Noah J. Schmidt, of Schmidt Salzman & Moran, Ltd. in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>*A Reduction*</u> in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND:	\$1,292
IMPR.:	\$38,662
TOTAL:	\$39,954

Subject only to the State multiplier as applicable.

## **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Property Tax Appeal Board pursuant to section 16-185 of the Property Tax Code (35 ILCS 200/16-185) challenging the assessment for the 2017 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

## **Findings of Fact**

The subject property consists of a two-story townhouse of masonry construction with 1,500 square feet of living area. The dwelling is approximately 20 years old. Features of the property include a partial basement with finished area, central air conditioning, one fireplace and a two-car garage. The property has a 760 square foot site located in Wilmette, New Trier Township, Cook County. The subject is classified as a class 2-95 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant, through counsel, contends the assessment of the subject property as established by the decision of the Property Tax Appeal Board (PTAB) for the 2016 tax year should be carried forward to the 2017 tax year pursuant to section 16-185 of the Property Tax Code. (35 ILCS 200/16-185). The appellant disclosed that the subject property is an owner-occupied residence that was the subject matter of an appeal before the Property Tax Appeal Board the prior year

under Docket Number 16-20718-R-1. In that appeal the PTAB issued a decision lowering the assessment of the subject property to \$39,954 based upon an agreement of the parties. The appellant asserted that tax years 2016 and 2017 are within the same general assessment period.

Alternatively, in support of the assessment inequity argument the appellant submitted information on five equity comparables improved with class 2-95, two-story dwellings of masonry or frame and masonry exterior construction that are located within the same neighborhood code as the subject. The comparables have other features with varying degrees of similarity when compared to the subject. The comparables have improvement assessments ranging from \$27,216 to \$32,897 or from \$18.83 to \$22.50 per square foot of living area.

In the supplemental brief, the appellant's attorney contends that since the time of the 2016 assessment reduction there have been no capital improvements made to the property which would materially increase the market value. The appellant's attorney requested the 2017 assessed valuation be revised so as not to exceed the PTAB's 2016 assessment. The PTAB's 2016 total assessment for the subject property was \$39,954 with an improvement assessment of \$38,662 or \$25.77 per square foot of living area

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$45,970. The subject property has an improvement assessment of \$44,678 or \$29.79 per square foot of living area. The subject's assessment reflects a market value of \$459,700, when using the 2017 when using the Cook County Real Property Assessment Classification Ordinance level of assessment for class 2 property of 10%. The board of review also reported that 2016 was the beginning of the subject's general assessment cycle and that no equalization factor was applied in 2017.

In support of its contention of the correct assessment, the board of review submitted information on four comparables improved with class 2-95, two-story dwellings that are located within the same neighborhood code as the subject. The comparables have other features similar to the subject. The comparables have improvement assessments ranging from \$44,678 to \$50,973 or from \$29.79 to \$31.86 per square foot of living area. The board of review also disclosed that a property within the subject's neighborhood sold in April 2016 for \$496,125 or \$330.75 per square foot of living area, including land. Based on this evidence, the board of review requested that the subject's assessment be confirmed.

## **Conclusion of Law**

The appellant, in part, raised a contention of law asserting that the assessment of the subject property as established by the Property Tax Appeal Board for the 2016 tax year should be carried forward to the 2017 tax year pursuant to section 16-185 of the Property Tax Code. (35 ILCS 200/16-185). When a contention of law is raised the burden of proof is a preponderance of the evidence. (See 5 ILCS 100/10-15). The Board finds the appellant met this burden of proof and a reduction in the subject's assessment is warranted on this basis.

Section 16-185 of the Property Tax Code (35 ILCS 200/16-185) states in part:

If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel on which a residence occupied by the owner is situated, such reduced assessment, subject to equalization, shall remain in effect for the remainder of the general assessment period as provided in Sections 9-215 through 9-225, unless that parcel is subsequently sold in an arm's length transaction establishing a fair cash value for the parcel that is different from the fair cash value on which the Board's assessment is based, or unless the decision of the Property Tax Appeal Board is reversed or modified upon review.

The record disclosed the Property Tax Appeal Board issued a decision reducing the subject's assessment for the 2016 tax year under Docket Number 16-20718-R-1. The record further indicates the subject property is an owner-occupied dwelling in accordance with section 16-185 of the Property Tax Code, and that 2016 and 2017 are within the same general assessment period. The record contains no evidence indicating the subject property sold in an arm's length transaction after the Board's decision or that the decision of the Property Tax Appeal Board has been reversed or modified upon review. For these reasons, the Property Tax Appeal Board finds that a reduction in the subject's assessment is warranted to reflect the assessment as established in the Board's decision for the previous tax year.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

# **IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND</u> <u>EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
