



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Sateesh Nagiseti

The parties of record before the Property Tax Appeal Board are Sateesh Nagiseti, the appellant, by attorney Ronald Kingsley, of Lake County Real Estate Tax Appeal, LLC in Lake Forest; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$20,370
IMPR.: \$75,706
TOTAL: \$96,076

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2018 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a two-story dwelling of wood siding exterior construction with 2,117 square feet of living area. The dwelling was constructed in 1995. Features of the home include a basement with finished area, central air conditioning and a 480 square foot garage. The property has a 9,583 square foot site and is located in Gurnee, Warren Township, Lake County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument the appellant submitted information on six comparable sales located within 0.32 of a mile from the subject property. The comparables have sites that range in size from 7,405 to 9,583 square feet of land area and are improved with two-story dwellings of wood siding exterior construction that range in size from 2,109 to 2,372 square feet of living area. The homes were built in 1994 or 1995. Each comparable has a basement, five with finished area, central air conditioning and a garage ranging in size from 441 to 480 square feet of building area. Four comparables each have

one fireplace. The comparables sold from January 2017 to February 2018 for prices ranging from \$245,000 to \$289,000 or from \$103.51 to \$136.51 per square foot of living area, land included. Based on this evidence, the appellant requested the subject's assessment be reduced to \$88,199.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$96,076. The subject's assessment reflects a market value of \$290,435 or \$137.19 per square foot of living area, land included, when using the 2018 three year average median level of assessment for Lake County of 33.08% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment the board of review submitted information on six comparable sales located within approximately 0.17 of a mile from the subject property. Board of review comparable #5 is the same property as the appellant's comparable #6. The comparables have sites that range in size from 8,712 to 12,632 square feet of land area and are improved with two-story dwellings of wood siding exterior construction that range in size from 2,109 to 2,372 square feet of living area. The homes were built in 1994 or 1995. Each comparable has a basement, five with finished area, central air conditioning and a garage ranging in size from 441 to 682 square feet of building area. Three comparables each have one fireplace. The comparables sold from March 2017 to June 2018 for prices ranging from \$289,000 to \$314,000 or from \$126.90 to \$148.36 per square foot of living area, land included. Based on this evidence, the board of review requested the subject's assessment be confirmed.

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The record contains 11 comparables for the Board's consideration as one comparable was common to both parties. The Board gave less weight to the appellant's comparables #1 and #4 along with board of review comparables #4 and #6 which differ from the subject in having unfinished basements compared to the subject's finished basement or a dissimilar site size when compared to the subject. The appellant's comparable #1 also appears to be an outlier based on its sale price per square foot relative to all other sales in the record.

The Board finds the best evidence of market value to be appellant's comparable sales #2, #3, #5 and #6/board of review comparable #5 along with board of review comparables #1, #2 and #3 which are similar to the subject in terms of location, age, design, dwelling size and features. These most similar comparables sold from January 2017 to June 2018 for prices ranging from \$267,500 to \$312,900 or from \$117.49 to \$148.36 per square foot of living area, including land. The subject's assessment reflects a market value of \$290,435 or \$137.19 per square foot of living area, including land, which falls within the range established by the best comparable sales in this

record. After considering adjustments to the comparables for differences with the subject, the Board finds a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
