



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Hitesh Patel

The parties of record before the Property Tax Appeal Board are Hitesh Patel, the appellant, by attorney Ronald Kingsley, of Lake County Real Estate Tax Appeal, LLC in Lake Forest; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds A Reduction in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$27,250
IMPR.: \$94,875
TOTAL: \$122,125

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2018 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a two-story dwelling of wood siding exterior construction with 3,516 square feet of living area. The dwelling was constructed in 2002. Features of the home include an unfinished basement, central air conditioning, a fireplace and a 598 square foot garage. The property has a 12,197 square foot site and is located in Lake Villa, Warren Township, Lake County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument the appellant submitted information on 11 comparable sales located within 0.36 of a mile from the subject property. The comparables have sites that range in size from 8,712 to 21,780 square feet of land area and are improved with a one-story and ten, two-story dwellings of wood siding exterior construction that range in size from 3,012 to 3,916 square feet of living area. The homes were built from 1996 to 2001. Each comparable has a basement, nine with finished area, central

air conditioning, one fireplace and a garage ranging in size from 546 to 765 square feet of building area. The comparables sold from November 2016 to January 2018 for prices ranging from \$290,000 to \$425,000 or from \$91.29 to \$113.64 per square foot of living area, land included. Based on this evidence, the appellant requested the subject's assessment be reduced to \$113,672.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$129,352. The subject's assessment reflects a market value of \$391,028 or \$111.21 per square foot of living area, land included, when using the 2018 three year average median level of assessment for Lake County of 33.08% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment the board of review submitted information on four comparable sales located within approximately 0.22 of a mile from the subject property. The comparables have sites that range in size to 11,761 to 13,068 square feet of land area and are improved with two-story dwellings of wood siding exterior construction that range in size from 3,414 to 3,586 square feet of living area. The homes were built from 1997 to 1999. Each comparable has a basement with finished area, central air conditioning, one fireplace and a garage ranging in size from 615 to 765 square foot of building area. The comparables sold from June 2017 to May 2018 for prices ranging from \$420,000 to \$455,000 or from \$119.61 to \$130.35 per square foot of living area, land included. Based on this evidence, the board of review requested the subject's assessment be confirmed.

Conclusion of Law

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant met this burden of proof and a reduction in the subject's assessment is warranted.

The parties submitted 15 comparables for the Board's consideration. The Board gave less weight to appellant comparable #1 which sold in 2016 and is dated and less indicative of fair market value as of the subject's January 1, 2018 assessment date. The Board gave less weight to appellant comparables #3, #4, #9, #10 and #11 due to significantly different dwelling sizes when compared to the subject. The Board gave little weight to appellant comparable #8 which has a significantly smaller site size compared to the subject's site.

The Board finds the best evidence of market value to be appellant's comparables #2, #5, #6 and #7 along with the board of review comparables which are more similar to the subject in terms of location, age, design, site size, dwelling size and features. Each of these eight best comparables differ from the subject in their finished basement feature compared to the subject's unfinished basement. These most similar comparables sold from June 2017 to May 2018 for prices ranging from \$343,000 to \$455,000 or from \$93.33 to \$130.35 per square foot of living area, including land. The subject's assessment reflects a market value of \$391,028 or \$111.21 per square foot of living area, including land, which falls within the range established by the best comparable sales

in this record, but appears to be excessive given the subject's unfinished basement. After considering adjustments to the comparables for differences with the subject, especially with respect to finished basement area, the Board finds a reduction in the subject's assessment is justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
