



**FINAL ADMINISTRATIVE DECISION  
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Radha Sura

The parties of record before the Property Tax Appeal Board are Radha Sura, the appellant, by attorney Gregory Riggs, of Tax Appeals Lake County in Lake Zurich; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$64,824  
**IMPR.:** \$157,163  
**TOTAL:** \$221,987

Subject only to the State multiplier as applicable.

**Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2018 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

**Findings of Fact**

The subject property consists of a two-story dwelling of brick exterior construction with 3,567 square feet of living area. The dwelling was constructed in 2004. Features of the home include an unfinished basement, central air conditioning, a fireplace and a 618 square foot garage. The property is located in Vernon Hills, Libertyville Township, Lake County.

The appellant contends overvaluation as the basis of the appeal. In support of this argument the appellant submitted information on eight comparable sales located from .12 to .78 of a mile from the subject property. The comparables have lot sizes ranging from 9,361 to 16,385 square feet of land area. The properties are improved with two-story dwellings of brick or wood siding exterior construction ranging in size from 3,321 to 4,090 square feet of living area. The dwellings were constructed from 2001 to 2004. The comparables each have an unfinished basement, central air conditioning and a garage ranging in size from 452 to 696 square feet of building area. Five

comparables each have a fireplace. The comparables sold from July 2017 to September 2018 for prices ranging from \$520,000 to \$680,000 or from \$140.55 to \$181.48 per square foot of living area, land included. Based on this evidence, the appellant requested a reduction in the subject's assessment.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$221,987. The subject's assessment reflects a market value of \$671,061 or \$188.13 per square foot of living area, land included, when using the 2018 three year average median level of assessment for Lake County of 33.08% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment the board of review submitted a grid analysis and property record cards for the subject and six comparable sales located within .7 of a mile from the subject property. Board of review comparables #5 and #6 are the same properties as the appellant's comparables #8 and #6, respectively. The comparables have sites ranging in size from 10,160 to 15,194 square feet of land area, four of which are located on the golf course.<sup>1</sup> The properties are improved with two-story dwellings of brick or wood siding exterior construction that range in size from 3,240 to 3,758 square feet of living area. The dwellings were constructed from 2000 to 2004. The comparables each have an unfinished basement, central air conditioning and a garage ranging in size from 598 to 696 square feet of building area. Five comparables each have one to three fireplaces. The comparables sold from May 2017 to August 2018 for prices ranging from \$616,000 to \$680,000 or from \$177.75 to \$190.12 per square foot of living area, land included. The board of review also indicated the subject sold via the Multiple Listing Service for \$645,000 on October 13, 2016. Based on this evidence, the board of review requested that the subject's assessment be confirmed.

### **Conclusion of Law**

The appellant contends the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The Board finds twelve comparable sales were submitted by the parties in support of their respective positions, with two comparables common to both parties. The Board finds these comparables are relatively similar to the subject in location, dwelling size, design, age and features. The comparables sold from May 2017 to September 2018 for prices ranging from \$520,000 to \$680,000 or from \$140.55 to \$190.12 per square foot of living area, including land. The subject's assessment reflects a market value of \$671,061 or \$188.13 per square foot of living area, including land, which falls within the range established by the comparable sales in this record. After considering adjustments to the comparables for any differences when compared to the subject, the Board finds the subject's estimated market value as reflected by its assessment is

supported. Based on this evidence, the Board finds a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

**IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
