

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: David & Jill Altman DOCKET NO.: 18-02311.001-R-1 PARCEL NO.: 16-32-315-001

The parties of record before the Property Tax Appeal Board are David & Jill Altman, the appellants, by Jessica Hill-Magiera, Attorney at Law in Lake Zurich; and the Lake County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Lake** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$61,409 **IMPR.:** \$131,746 **TOTAL:** \$193,155

Subject only to the State multiplier as applicable.

#### **Statement of Jurisdiction**

The appellants timely filed the appeal from a decision of the Lake County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2018 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

#### **Findings of Fact**

The subject property consists of a two-story dwelling of brick exterior construction with 2,520 square feet of living area. The dwelling was constructed in 1971. Features of the home include an unfinished basement, central air conditioning, a fireplace and a 483 square foot garage. The property is located in Lake Zurich, West Deerfield Township, Lake County.

The appellants contend overvaluation as the basis of the appeal. In support of this argument the appellants submitted information on eight comparable sales located within 0.37 of a mile from the subject property. The comparables are improved with two-story dwellings of brick exterior construction that range in size from 2,159 to 2,888 square feet of living area. The homes were built from 1970 to 1977. Each comparable has an unfinished basement, central air conditioning, one or two fireplaces and a garage ranging in size from 440 to 581 square feet of building area. The comparables sold from March 2017 to May 2018 for prices ranging from \$381,500 to

\$575,000 or from \$160.50 to \$219.53 per square foot of living area, land included. Based on this evidence, the appellants requested the subject's assessment be reduced to \$157,076.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$193,155. The subject's assessment reflects a market value of \$583,903 or \$231.71 per square foot of living area, land included, when using the 2018 three year average median level of assessment for Lake County of 33.08% as determined by the Illinois Department of Revenue.

In support of its contention of the correct assessment the board of review submitted information on six comparable sales located within approximately 0.28 of a mile from the subject property. Board of review comparable #6 is also presented by the appellants as comparable #8. The comparables are improved with two-story dwellings of brick or wood siding exterior construction that range in size from 2,152 to 2,586 square feet of living area. The homes were built from 1970 to 1977. Each comparable has a basement, two with finished area, central air conditioning and a garage ranging in size from 440 to 506 square feet of building area. Five of the comparables each have one fireplace. The comparables sold from February to September 2017 for prices ranging from \$475,000 to \$690,900 or from \$219.53 to \$270.03 per square foot of living area, land included. Based on this evidence, the board of review requested the subject's assessment be confirmed.

# **Conclusion of Law**

The appellants contend the market value of the subject property is not accurately reflected in its assessed valuation. When market value is the basis of the appeal the value of the property must be proved by a preponderance of the evidence. 86 Ill.Admin.Code §1910.63(e). Proof of market value may consist of an appraisal of the subject property, a recent sale, comparable sales or construction costs. 86 Ill.Admin.Code §1910.65(c). The Board finds the appellants did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The record contains 13 comparables for the Board's consideration as one comparable was common to both parties. The Board gave less weight to the appellants' comparables #3, #5 and #6 which are dissimilar in dwelling size when compared to the subject. The Board gave less weight to board of review comparables #3 and #5 which have finished basements compared to the subject's unfinished basement. Board of review comparable #5 also has a dissimilar dwelling size compared to the subject.

The Board finds the best evidence of market value to be appellants' comparables #1, #2, #4, #7 and #8/board of review comparable #6 along with board of review comparables #1, #2 and #4 which are similar to the subject in location, age, design, dwelling size and features. These most similar comparables sold from February 2017 to May 2018 for prices ranging from \$381,500 to \$687,500 or from \$160.50 to \$270.03 per square foot of living area, including land. The subject's assessment reflects a market value of \$583,903 or \$231.71 per square foot of living area, including land, which falls within the range established by the best comparable sales in this record. After considering adjustments to the comparables for differences with the subject, the Board finds a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

#### **IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
