



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

The parties of record before the Property Tax Appeal Board are John Gathercoal, the appellant, by Amy C. Floyd, Attorney at Law in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds ***no change*** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$4,882
IMPR.: \$14,483
TOTAL: \$19,365

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2018 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a one-story dwelling of masonry exterior construction with 1,072 square feet of living area. The dwelling is approximately 61 years old. Features of the home include a full unfinished basement and a one-car garage. The property has a 6,300 square foot site and is located in Glenview, Maine Township, Cook County. The subject is classified as a class 2-03 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument, the appellant submitted information on four equity comparables located within the same assessment neighborhood code as the subject property. The comparables are improved with class 2-03 one-story dwellings of frame or masonry exterior construction ranging in size from 1,106 to 1,679 square feet of living area. The dwellings are 59 or 63 years old. One comparable has a concrete slab foundation and the three remaining

comparables have full basements, one of which has a recreation room. Three comparables have central air conditioning and two comparables each have one fireplace. The comparables have improvement assessments that range from \$6,268 to \$14,378 or from \$5.67 to \$8.95 per square foot of living area. Based on this evidence, the appellant requested the subject's improvement assessment be reduced to \$7,858 or \$7.33 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$19,365. The subject property has an improvement assessment of \$14,483 or \$13.51 per square foot of living area.

In support of its contention of the correct assessment, the board of review submitted information on four equity comparables located within the same assessment neighborhood code as the subject property. The comparables are improved with class 2-03 one-story dwellings of masonry exterior construction ranging in size from 1,053 to 1,169 square feet of living area. The dwellings range in age from 61 to 64 years old. One comparable has a crawl space foundation and the three remaining comparables each have a full or partial basement, two of which have recreation rooms. One comparable has a fireplace and three comparables each have either a one-car or a two-car garage. The comparables have improvement assessments that range from \$16,693 to \$23,145 or from \$14.28 to \$20.85 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties provided eight suggested equity comparables to support their respective positions before the Property Tax Appeal Board. The Board gives less weight to the appellant's comparables due to differences from the subject in dwelling size and/or features, as one of the comparables has a concrete slab foundation in contrast to the subject dwelling which has a full unfinished basement and none of the comparables are described as having a garage as does the subject property. The Board gives reduced weight to board of review comparables #2 and #3 which differ from the subject in that comparable #2 lacks a garage and comparable #3 lacks a basement.

The Board finds the best evidence of assessment equity to be board of review comparables #1 and #4. These comparables are relatively similar to the subject in dwelling size, design, age and features, except one comparable has a recreation room in its basement, not a feature the subject enjoys, suggesting a downward adjustment for this feature would be required to make this comparable more equivalent to the subject. The comparables have improvement assessments of \$16,693 and \$21,501 or \$14.28 and \$20.13 per square foot of living area, respectively. The

subject's improvement assessment of \$14,483 or \$13.51 per square foot of living area is below the two best comparables in the record both in terms of overall improvement assessment and on a square foot basis. After considering adjustments to the comparables for differences from the subject, the Board finds the subject's assessment is supported. Based on this record, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
