



**FINAL ADMINISTRATIVE DECISION  
ILLINOIS PROPERTY TAX APPEAL BOARD**

The parties of record before the Property Tax Appeal Board are Lauren Flahive, the appellant, by attorney Spiro Zarkos, of Verros Berkshire, PC in Chicago, and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$3,402  
**IMPR.:** \$27,914  
**TOTAL:** \$31,316

Subject only to the State multiplier as applicable.

**Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2018 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

**Findings of Fact**

The subject property consists of a 1.5-story dwelling of masonry exterior construction with 1,621 square feet of living area. The dwelling is approximately 65 years old. Features of the home include a full basement with a finished recreation room and a two-car garage. The property has a 5,040 square foot site and is located in Niles, Maine Township, Cook County. The subject is classified as a class 2-03 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument, the appellant submitted information on four comparables located within the same assessment neighborhood code as the subject. The comparables are improved with class 2-03 one-story dwellings of masonry exterior construction that range in size

from 1,104 to 1,482 square feet of living area and are 62 years old.<sup>1</sup> Two comparables have partial or full basements with finished recreation rooms. Two comparables have concrete slab foundations. Two comparables have central air conditioning. Three comparables have one-car or two-car garages. The comparables have improvement assessments ranging from \$12,663 to \$17,325 or from \$10.57 to \$11.77 per square foot of living area. Based on this evidence, the appellant requested a reduction in the subject's improvement assessment to \$18,447 or \$11.38 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$31,316. The subject has an improvement assessment of \$27,914 or \$17.22 per square foot of living area. In support of its contention of the correct assessment the board of review submitted information on three equity comparables that are located within the same assessment neighborhood code as the subject. The comparables are improved with class 2-03, 1.5-story dwellings of masonry exterior construction that range in size from 1,290 to 1,381 square feet of living area and are 62 or 63 years old. The comparables have full basements with finished recreation rooms and two car garages. Two comparables have central air conditioning. One comparable has a fireplace. The comparables have improvement assessments ranging from \$26,336 to \$27,923 or from \$19.07 to \$21.65 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

### **Conclusion of Law**

The appellant contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The record contains seven equity comparables for the Board's consideration. The Board gave less weight to the appellant's comparables due to their dissimilar one-story design, lack of basement foundations and/or garages when compared to the subject.

The Board finds the best evidence of assessment equity to be the board of review comparables which are most similar to the subject in design, age and features. These comparables have improvement assessments ranging from \$26,336 to \$27,923 or from \$19.07 to \$21.65 per square foot of living area. The subject's improvement assessment of \$27,914 or \$17.22 per square foot of living area is within the range on an overall improvement assessment basis established by the best comparables in this record and falls below the range on a per square foot basis. Based on this record and after considering adjustments to the comparables for differences when compared to the subject, the Board finds the appellant failed to prove by clear and convincing evidence that the subject's improvement is inequitably assessed and a reduction in the subject's assessment is not justified.

**IMPORTANT NOTICE**

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
