

# FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Ferris Hussein, the appellant, by attorney Peter D. Verros of Verros Berkshire, PC in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>no change</u> in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

**LAND:** \$11,016 **IMPR.:** \$61,724 **TOTAL:** \$72,740

Subject only to the State multiplier as applicable.

#### **Statement of Jurisdiction**

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2018 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

#### **Findings of Fact**

The subject property consists of a two-story, multi-family building of masonry exterior construction with 5,774 square feet of building area. The dwelling is approximately 89 years old. Features of the building include a full unfinished basement and a three-car garage. The property has an 8,160 square foot site and is located in Evanston, Evanston Township, Cook County. The subject is classified as a class 2-11 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument, the appellant submitted information on four equity comparables located within the same assessment neighborhood code as the subject property. The comparables are improved with class 2-11, multi-family buildings of masonry or frame and masonry exterior construction ranging in size from 3,466 to 9,450 square feet of building area.

The buildings range in age from 104 to 123 years old. Each comparable has a full basement, one of which has an apartment. One comparable has central air conditioning and two comparables have either a 1.5-car or a 4-car garage. The comparables have improvement assessments that range from \$22,808 to \$84,105 or from \$6.58 to \$9.24 per square foot of building area. Based on this evidence, the appellant requested the subject's improvement assessment be reduced to \$49,021 or \$8.49 per square foot of building area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$72,740. The subject property has an improvement assessment of \$61,724 or \$10.69 per square foot of building area. In support of its contention of the correct assessment, the board of review submitted information on four equity comparables, two of which are located within the same assessment neighborhood code and within ¼ of a mile from the subject property.¹ The comparables are improved with class 2-11, two-story or three-story multifamily buildings of masonry exterior construction. Each comparable has a full unfinished basement, one comparable has central air conditioning, one comparable has three fireplaces and two comparables each have either a 2-car or a 3.5-car garage. The comparables have improvement assessments that range from \$63,797 to \$91,179 or from \$11.56 to \$15.53 per square foot of building area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

## **Conclusion of Law**

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The record contains eight suggested equity comparables for the Board's consideration. The Board gives less weight to the appellant's comparables due to their dissimilar building sizes when compared to the subject. The Board gives reduced weight to board of review comparable #4 due to its dissimilar three-story design when compared to the subject's two-story design. The Board finds the best evidence of assessment equity to be board of review comparables #1, #2 and #3. These comparables are relatively similar to the subject in location, design and some features, and most similar to the subject in building size. The comparables have improvement assessments that range from \$63,797 to \$91,179 or from \$11.56 to \$15.53 per square foot of building. The subject's improvement assessment of \$61,724 or \$10.69 per square foot of building area falls below the range established by the best comparables in the record. After considering adjustments to the comparables for differences from the subject, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

The Property Tax Appeal Board does not require any motion or request for reconsideration.

## IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
