

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: James Kenny DOCKET NO.: 18-24265.001-R-1 PARCEL NO.: 04-24-300-008-0000

The parties of record before the Property Tax Appeal Board are James Kenny, the appellant, by attorney Noah J. Schmidt, of Schmidt Salzman & Moran, Ltd. in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>A Reduction</u> in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$25,953 **IMPR.:** \$65,928 **TOTAL:** \$91,881

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2018 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 1.5-story dwelling of frame and masonry exterior construction with 4,369 square feet of living area. The dwelling is approximately 64 years old. Features of the home include a concrete slab foundation, central air conditioning, one fireplace, and a three-car garage. The property has a 43,255 square foot site and is located in Northfield, Northfield Township, Cook County. The subject is classified as a class 2-04 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument, the appellant submitted information on five equity comparables that are located in the same neighborhood code as the subject. The comparables are improved with class 2-04, 1-story or "1.5-1.9-story" dwellings of frame, masonry or frame and masonry exterior construction ranging in size from 4,146 to 4,495 square feet of living area. The

comparables range in age from 58 to 75 years old. Four comparables have partial unfinished or full finished basements. Each comparable has central air conditioning, from one to three fireplaces, and either a two-car or a three-car garage. The comparables have improvement assessments ranging from \$61,887 to \$74,932 or from \$14.93 to \$16.67 per square foot of living area. Based on this evidence, the appellant requested that the subject's improvement assessment be reduced to \$65,928 or \$15.09 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$103,284. The subject property has an improvement assessment of \$77,331 or \$17.70 per square foot of living area. In support of its contention of the correct assessment, the board of review submitted information on four equity comparables that are located within the same neighborhood code and the same block as the subject property. The comparables are improved with class 2-04, 1-story or 1.5-story dwellings of masonry or frame and masonry exterior construction ranging in size from 2,207 to 3,248 square feet of living area. The comparables range in age from 61 to 65 years old. One comparable has concrete slab foundation, and three comparables have partial unfinished basements. Each comparable has central air conditioning and one or two fireplaces. Three comparables have either a two-car or a three-car garage. The comparables have improvement assessments ranging from \$41,611 to \$70,410 or from \$18.31 to \$21.68 per square foot of living area. Based on this evidence, the board of review requested that the subject's assessment be confirmed.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant met this burden of proof and a reduction in the subject's assessment is warranted.

The parties submitted nine suggested comparables for the Board's consideration, all of which have a dissimilar 1-story design and/or a basement, unlike the subject dwelling's 1.5-story design that lacks a basement. The Board gives less weight to the board of review comparables due to their considerably smaller dwelling sizes when compared to the subject's dwelling.

The Board finds the best evidence of assessment equity to be the appellant's comparables which are similar to the subject in location, age, and dwelling size, but differ from the subject in design, basement foundation, and/or other features. These five comparables have improvement assessments ranging from \$61,887 to \$74,932 or from \$14.93 to \$16.67 per square foot of living area. The subject's improvement assessment of \$77,331 or \$17.70 per square foot of living area falls above the range established by the best comparables in this record. After considering adjustments to the comparables for differences from the subject, the Board finds the appellant demonstrated with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's improvement assessment based on inequity commensurate with the appellant's request is warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
