

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

The parties of record before the Property Tax Appeal Board are Konstantinos Rousis, the appellant, by attorney George N. Reveliotis, of Reveliotis Law, P.C. in Park Ridge; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds <u>*A Reduction*</u> in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND:	\$6,825
IMPR.:	\$16,380
TOTAL:	\$23,205

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2018 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a multi-level dwelling of frame and masonry exterior construction with 1,365 square feet of living area. The dwelling is approximately 45 years old. Features of the dwelling include a partial basement with finished area and a 2-car garage. The property has a 10,500 square foot site and is located in Willow Springs, Lyons Township, Cook County. The subject is classified as a class 2-34 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument, the appellant submitted information on eight equity comparables that are located within the same neighborhood code as the subject. The comparables are improved with class 2-34, multi-level dwellings of frame, masonry, or frame and masonry exterior construction ranging in size from 1,057 to 1,494 square feet of living area.

The dwellings range in age from 42 to 56 years old, and each comparable has a partial basement with finished area. One comparable has a fireplace, and seven comparables each have a 2-car garage. Based upon the response in the appellant's grid analysis, the Board is unable to determine if the comparables have air conditioning. The comparables have improvement assessments ranging from \$8,215 to \$17,480 or from \$7.77 to \$12.03 per square foot of living area. Based on this evidence, the appellant requested that the subject's improvement assessment be reduced to \$14,698 or \$10.77 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$24,175. The subject property has an improvement assessment of \$17,350 or \$12.71 per square foot of living area. In support of its contention of the correct assessment, the board of review submitted information on four equity comparables that are located within the same neighborhood code as the subject. The comparables are improved with class 2-34, multi-level dwellings of frame and masonry exterior construction with 1,033 or 1,323 square feet of living area. The dwellings are 44 or 53 years old, and each has a partial basement with finished area. Two comparables each have central air conditioning, one comparable has a fireplace, and each comparable has a 2-car or a 2.5-car garage. The comparables have improvement assessments ranging from \$15,917 to \$18,441 or from \$12.03 to \$17.85 per square foot of living area. Based on this evidence, the board of review requested that the subject's assessment be confirmed.

Conclusion of Law

The appellant contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant met this burden of proof and a reduction in the subject's assessment is warranted.

The parties submitted twelve suggested comparables for the Board's consideration. The Board recognizes the appellant's comparable #1 is the same property as the board of review comparable #4 which is located at 8611 Dunbar Street in Willow Springs. The Board gives less weight to the appellant's comparable #8 and the board of review comparables #1 through #3 due to their considerably smaller dwelling sizes when compared to the subject dwelling.

The Board finds the best evidence of assessment equity to be both parties' remaining comparables. These eight comparables are most similar to the subject in location, design, dwelling size, foundation, and some features. These eight comparables have improvement assessments ranging from \$9.00 to \$12.03 per square foot of living area. The subject's improvement assessment of \$12.71 per square foot of living area falls above the range established by the best comparables contained in this record. Based on this record, the Board finds the appellant demonstrated with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND</u> <u>EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
