

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: Katrina Mulac DOCKET NO.: 18-31783.001-R-1 PARCEL NO.: 13-07-405-035-0000

The parties of record before the Property Tax Appeal Board are Katrina Mulac, the appellant, by attorney Noah J. Schmidt, of Schmidt Salzman & Moran, Ltd. in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$6,200 **IMPR.:** \$31,032 **TOTAL:** \$37,232

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2018 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a 2-story dwelling of masonry exterior construction with 2,111 square feet of living area. The dwelling is approximately 75 years old. Features of the home include a basement with finished area, 2 full & 2 half bathrooms, and central air conditioning. The property has a 4,960 square foot site and is located in Chicago, Jefferson Township, Cook County. The subject is classified as a class 2-05 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument, the appellant submitted information on two grid analyses for five equity comparables with the same neighborhood code as the subject property. For clarity in the record, the comparable on the second grid analysis has been renumbered #5. The comparables are improved with 2-story dwellings of frame or frame and masonry exterior

construction ranging in size from 1,981 to 2,200 square feet of living area. The homes range in age from 66 to 94 years old. Four comparables each have a basement with two having finished area. Three comparables each have central air conditioning. Each comparable has 2.0 or 2.5 bathrooms. Four comparables each have a 2-car garage. The comparables have improvement assessments that range from \$22,390 to \$25,808 or from \$11.26 to \$11.85 per square foot of living area. Based on this evidence, the appellant requested the subject's improvement assessment be reduced to \$24,023 or \$11.38 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$37,232. The subject property has an improvement assessment of \$31,032 or \$14.70 per square foot of living area.

In support of its contention of the correct assessment, the board of review submitted information on four equity comparables with the same neighborhood code as the subject property. The comparables are improved with 2-story class 2-05 dwellings of masonry or frame and masonry exterior construction ranging in size from 1,439 to 1,923 square feet of living area. The homes range in age from 71 to 74 years old. Each comparable has a basement with two having finished area, 2.0 or 2.5 bathrooms, and a 2-car garage. Three comparables each have central air conditioning. One comparable has one fireplace. The comparables have improvement assessments that range from \$21,279 to \$30,272 or from \$14.79 to \$18.43 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The parties submitted nine suggested comparables for the Board's consideration. The Board gives less weight to the appellant's comparables #3, #4, and #5 as well as board of review comparables #3 and #4 which differ from the subject in age, dwelling size and/or lacks a basement foundation, which is a feature of the subject.

The Board finds the best evidence of assessment equity to be the appellant's comparable #1 and #2 as well as board of review comparables #1 and #2 which are similar to the subject in age and dwelling size. However, each comparable has differences when compared to the subject in other features requiring various adjustments to make them more equivalent to the subject. Each comparable has fewer bathrooms than the subject. Four comparables each have a two-car garage and one comparable has one fireplace, both features the subject lacks. Nevertheless, the five properties have improvement assessments ranging from \$22,390 to \$30,272 or from \$11.26 to

\$15.74 per square foot of living area. The subject's improvement assessment of \$31,032 or \$14.70 per square foot of living area falls above the range established by the best comparables in this record on an overall basis but within the range on a per square foot basis. However, based on the record and after considering various adjustments for differences from the subject such as but not limited to the comparables' smaller dwelling sizes, garage and fireplace amenities, and smaller bathroom counts, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's improvement assessment based on inequity is not warranted.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

Section 16-185 of the Property Tax Code provides in part:

IMPORTANT NOTICE

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
