



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: 3743 Armitage LLC

The parties of record before the Property Tax Appeal Board are 3743 Armitage LLC, the appellant(s), by attorney Brian P. Liston, of the Law Offices of Liston & Tsantilis, P.C. in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **No Change** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$4,531
IMPR.: \$38,042
TOTAL: \$42,573

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2018 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property contains two residential improvements situated on one parcel. Improvement #1 is a 110-year-old, three-story dwelling of masonry construction containing 3,798 square feet of living area. Features of Improvement #1 include a partial unfinished basement. Improvement #2 is a 131-year-old, two-story dwelling of frame construction containing 2,101 square feet of living area. Features of Improvement #2 include a crawl space. The property is situated on 3,125 square feet of land in Jefferson Township, Cook County. It is a Class 2 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity as the basis of the appeal. In support of this argument, the appellant submitted descriptive and assessment information on three suggested

equity comparables for only Improvement #1. The appellant did not submit information on Improvement #2. However, the appellant also listed the total for both improvement assessments when calculating the improvement assessment per square foot of Improvement #1. The appellant requested a total assessment reduction to \$29,978.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$42,573. The land assessment was \$4,531. Improvement #1 has an improvement assessment of \$28,473, or \$7.49 per square foot of living area. Improvement #2 has an improvement assessment of \$9,569, or \$4.55 per square foot of living area.¹ In support of its contention of the correct assessment, the board of review submitted descriptive and assessment information on four suggested equity comparables for Improvement #1, and four suggested equity comparables for Improvement #2.

Conclusion of Law

The appellant contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The Board finds the best evidence of Improvement #1 assessment equity to be the appellant's comparable(s) #2, and the board of review's comparable(s) #1, #3 and #4. These comparables had improvement assessments that ranged from \$6.70 to \$12.30 per square foot of living area. The assessment for Improvement #1 of \$7.49 per square foot of living area falls within the range established by the best comparables in this record. The Board finds the best evidence of Improvement #2 assessment equity to be the board of review's comparables #1 through #4. These comparables had improvement assessments that ranged from \$18.76 to \$20.32 per square foot of living area. The assessment for Improvement #2 of \$4.55 per square foot of living area falls below the range established by the best comparables in this record. Based on this record, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and holds that a reduction in the subject's assessment is not justified.

¹ The board of review cited \$38,042 for the assessment for Improvement #1 by subtracting the land assessment from the total assessment of the entire two-improvement subject. This calculation did not adjust for the assessment for Improvement #2. Hence, the Board readjusts the assessment for Improvement #1 to \$28,473 (TAV \$42,573 less LAV \$4,531 less Improvement #2 IAV \$9,569).

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, **YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS.** A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
