

FINAL ADMINISTRATIVE DECISION ILLINOIS PROPERTY TAX APPEAL BOARD

APPELLANT: National Home Rentals

The parties of record before the Property Tax Appeal Board are National Home Rentals, the appellant, by attorney Peter D. Verros, of Verros Berkshire, PC in Chicago; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds *No Change* in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$2,404 **IMPR.:** \$4,456 **TOTAL:** \$6,860

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2018 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a one-story dwelling of masonry exterior construction with 1,261 square feet of living area. The dwelling is approximately 66 years old. Features of the home include a concrete slab foundation and a two-car garage. The property has an 8,015 square foot site and is located in Park Forest, Rich Township, Cook County. The subject is classified as a class 2-03 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument, the appellant submitted information on four comparables located within the subject's assessment neighborhood code and from .4 of a mile to 1.6 miles from the subject. The comparables are improved with a 1.5-1.9-story and three, 1-story class 2-03 dwellings of frame and masonry exterior construction that range in size from 1,225 to 1,394

square feet of living area and range in age from 62 to 66 years old. One comparable has central air conditioning and each comparable has a 1-car, a 1.5-car or a 2-car garage. The comparables have improvement assessments ranging from \$2,867 to \$3,292 or from \$2.33 to \$2.53 per square foot of living area. Based on this evidence, the appellant requested a reduction in the subject's improvement assessment to \$3,039 or \$2.41 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$6,860. The subject has an improvement assessment of \$4,456 or \$3.53 per square foot of living area.

In support of its contention of the correct assessment the board of review submitted information on four equity comparables located within the same assessment neighborhood code as the subject. The comparables are improved with one-story, class 2-03 dwellings of masonry exterior construction that range in size from 1,175 to 1,285 square feet of living area and are either 58 or 66 years old. The comparables have concrete slab foundations, one comparable has central air conditioning and each comparable has a one-car or a two-car garage. The comparables have improvement assessments ranging from \$4,355 to \$5,243 or from \$3.61 to \$4.08 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The appellant contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject. The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The record contains eight equity comparables for the Board's consideration. The Board gave less weight to the appellant's comparables #1 and #3 due to their distant location being over 1 mile from the subject and/or dissimilar story height when compared to the subject. The Board gave less weight to board of review comparable #4 due to its dissimilar age when compared to the subject.

The Board finds the best evidence of assessment equity to be appellant's comparables #2 and #4 along with board of review comparables #1, #2 and #3 which are identical in age and overall are more similar to the subject in location, dwelling size, and features. The best comparables have improvement assessments ranging from \$2,867 to \$4,553 or from \$2.34 to \$3.78 per square foot of living area. The subject's improvement assessment of \$4,456 or \$3.53 per square foot of living area is within the range established by the best comparables in this record. After considering adjustments to the comparables for differences when compared to the subject, the Board finds the subject's improvement assessment is equitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A <u>PETITION AND EVIDENCE</u> WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
