



**FINAL ADMINISTRATIVE DECISION
ILLINOIS PROPERTY TAX APPEAL BOARD**

APPELLANT: Ron Plonis

The parties of record before the Property Tax Appeal Board are Ron Plonis, the appellant, by attorney Peter D. Verros of Verros Berkshire in Oakbrook Terrace; and the Cook County Board of Review.

Based on the facts and exhibits presented in this matter, the Property Tax Appeal Board hereby finds **no change** in the assessment of the property as established by the **Cook** County Board of Review is warranted. The correct assessed valuation of the property is:

LAND: \$1,749
IMPR.: \$6,094
TOTAL: \$7,843

Subject only to the State multiplier as applicable.

Statement of Jurisdiction

The appellant timely filed the appeal from a decision of the Cook County Board of Review pursuant to section 16-160 of the Property Tax Code (35 ILCS 200/16-160) challenging the assessment for the 2018 tax year. The Property Tax Appeal Board finds that it has jurisdiction over the parties and the subject matter of the appeal.

Findings of Fact

The subject property consists of a one-story dwelling of frame exterior construction with 971 square feet of living area. The dwelling is approximately 52 years old. Features of the home include a concrete slab foundation and a 1-car garage. The property has a 6,360 square foot site and is located in Glenwood, Bloom Township, Cook County. The subject is classified as a class 2-02 property under the Cook County Real Property Assessment Classification Ordinance.

The appellant contends assessment inequity with respect to the improvement as the basis of the appeal. In support of this argument, the appellant submitted a grid analysis and property characteristic sheets for the subject and four comparable properties. The comparables have the same assessment neighborhood code as the subject and are located within .7 of a mile from the subject property. The comparables are improved with class 2-02 one-story dwellings of frame exterior construction ranging in size from 936 to 994 square feet of living area. The dwellings

range in age from 49 to 101 years old. One comparable has a concrete slab foundation, three comparables have full unfinished basements and each comparable has either a 1-car, a 1.5-car or a 2.5-car garage. Comparable #4 has central air conditioning. The comparables have improvement assessments that range from \$2,911 to \$4,687 or from \$3.11 to \$4.99 per square foot of living area. Based on this evidence, the appellant requested the subject's improvement assessment be reduced to \$4,107 or \$4.23 per square foot of living area.

The board of review submitted its "Board of Review Notes on Appeal" disclosing the total assessment for the subject of \$7,843. The subject property has an improvement assessment of \$6,094 or \$6.28 per square foot of living area.

In support of its contention of the correct assessment, the board of review submitted a grid analysis of the subject and four comparable properties located within the same neighborhood code and block as the subject property. The comparables are improved with class 2-02 one-story dwellings of frame exterior construction with either 867 or 913 square feet of living area. The dwellings are 45 or 52 years old. Each comparable has a full unfinished basement. Comparable #3 has a 2-car garage. The comparables have improvement assessments that range from \$6,398 to \$6,936 or from \$7.38 to \$7.60 per square foot of living area. Based on this evidence, the board of review requested confirmation of the subject's assessment.

Conclusion of Law

The taxpayer contends assessment inequity as the basis of the appeal. When unequal treatment in the assessment process is the basis of the appeal, the inequity of the assessments must be proved by clear and convincing evidence. 86 Ill.Admin.Code §1910.63(e). Proof of unequal treatment in the assessment process should consist of documentation of the assessments for the assessment year in question of not less than three comparable properties showing the similarity, proximity and lack of distinguishing characteristics of the assessment comparables to the subject property. 86 Ill.Admin.Code §1910.65(b). The Board finds the appellant did not meet this burden of proof and a reduction in the subject's assessment is not warranted.

The record contains eight suggested equity comparables for the Board's consideration. The Board finds none of these comparables are truly similar to the subject due to significant differences in age and/or features. Nevertheless, the Board gives less weight to the appellant's comparables #1, #2 and #4 due to their older dwelling ages when compared to the subject.

The Board finds the best evidence of assessment equity to be appellant's comparable #3 and the comparables presented by the board of review, which are overall most similar to the subject in location and age, and similar to the subject in dwelling size and design. However, the board of review comparables each have an unfinished basement, unlike the subject's concrete slab foundation, suggesting downward adjustments would be required to make these comparables more equivalent to the subject. In addition, three of the board of review comparables lack a garage in contrast to the subject which has a 1-car garage, suggesting upward adjustments would be required. The comparables have improvement assessments that range from \$4,687 to \$6,936 or from \$4.85 to \$7.60 per square foot of living area. The subject's improvement assessment of \$6,094 or \$6.28 per square foot of living area falls within the range established by the best comparables in this record both in terms of overall improvement assessment and on a per square

foot basis. After considering adjustments to the best comparables for differences from the subject, the Board finds the subject's improvement assessment is supported. Based on this record, the Board finds the appellant did not demonstrate with clear and convincing evidence that the subject's improvement was inequitably assessed and a reduction in the subject's assessment is not justified.

This is a final administrative decision of the Property Tax Appeal Board which is subject to review in the Circuit Court or Appellate Court under the provisions of the Administrative Review Law (735 ILCS 5/3-101 et seq.) and section 16-195 of the Property Tax Code. Pursuant to Section 1910.50(d) of the rules of the Property Tax Appeal Board (86 Ill.Admin.Code §1910.50(d)) the proceeding before the Property Tax Appeal Board is terminated when the decision is rendered. The Property Tax Appeal Board does not require any motion or request for reconsideration.

IMPORTANT NOTICE

Section 16-185 of the Property Tax Code provides in part:

"If the Property Tax Appeal Board renders a decision lowering the assessment of a particular parcel after the deadline for filing complaints with the Board of Review or after adjournment of the session of the Board of Review at which assessments for the subsequent year or years of the same general assessment period, as provided in Sections 9-125 through 9-225, are being considered, the taxpayer may, within 30 days after the date of written notice of the Property Tax Appeal Board's decision, appeal the assessment for such subsequent year or years directly to the Property Tax Appeal Board."

In order to comply with the above provision, YOU MUST FILE A PETITION AND EVIDENCE WITH THE PROPERTY TAX APPEAL BOARD WITHIN 30 DAYS OF THE DATE OF THE ENCLOSED DECISION IN ORDER TO APPEAL THE ASSESSMENT OF THE PROPERTY FOR THE SUBSEQUENT YEAR OR YEARS. A separate petition and evidence must be filed for each of the remaining years of the general assessment period.

Based upon the issuance of a lowered assessment by the Property Tax Appeal Board, the refund of paid property taxes is the responsibility of your County Treasurer. Please contact that office with any questions you may have regarding the refund of paid property taxes.
